

**ORDINANCE NO. 20 - \_\_\_\_**

**AN ORDINANCE AMENDING THE NAPERVILLE  
TRAFFIC SCHEDULE TO ESTABLISH  
SPEED LIMITS FOR ATWATER SUBDIVISION**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, ILLINOIS, DuPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority as follows:

**SECTION 1:** Schedule IV, Speed Limits, of the Naperville Traffic Schedule
