1. Consider Heinen's request to allow Class G1 licensees to obtain a Dispenser Permit

Jeff Heinen from Heinen's presented their request for a text amendment to allow Class G-1 licenses the ability to have a dispenser permit.

They currently service wine and beer in all 4 of their Chicago locations
Compared to Mariano's, they don't have a bar, limited store hours, no tvs, beer and wine cruvinet are more for samples as guests shop. It's not a hangout.
Commissions asked who is monitoring the liquor sales: all BASSET trained, wine and beer consultants on duty
Wine - guests purchase a reloadable card, guests are carded, press for wine service
1oz, 3oz, 5oz wine sizes
Beer - is served by an employee
2 glass maximum for beer
A text amendment is needed. Recommendation to the City Council at the February meeting.

A motion was made by Chirico, seconded by Douglas, approved and referred to the City Council. The motion carried by a unanimous vote.
