

**AFFIDAVIT OF NOTICE
REGARDING REQUESTED GROUNDWATER ORDINANCE
FOR NAPER BLVD. AND HOBSON OAKS DRIVE [MARKET MEADOWS]**

NOW COMES Daniel M. Caplice with K-Plus Engineering Services, LLC on behalf of Mid-America Asset Management, Inc., who, having been duly sworn, does hereby depose and state under oath as follows:

1. Mid-America Asset Management, Inc. is the owner of two properties within the City of Naperville located on Naper Blvd., and having Parcel Index Numbers (PINs) 08-29-203-005 and 08-29-203-007 (referenced herein as “**Commercial Properties**”).
2. As Environmental Engineer contracted with Mid-America Asset Management, Inc., I have been authorized to give the Notice described herein and to execute this Affidavit.
3. Mid-America Asset Management, Inc. is seeking issuance of a No Further Remediation (“**NFR**”) Letter from the Illinois Environmental Protection Agency (“**IEPA**”) as to the Commercial Properties.
4. In order to obtain an NFR from the IEPA for the Commercial Properties, Mid-America Asset Management, Inc. is seeking approval by the Naperville City Council of an institutional control known as a Groundwater Ordinance which will prohibit the use, or the attempt to use as a potable water supply, groundwater within the area covered by the Groundwater Ordinance.) The proposed Groundwater Ordinance, if approved, will be recorded with the DuPage County Recorder against the Commercial Properties as well as other properties adjacent thereto (“**Other Properties**”).
5. Prior to consideration of the proposed Groundwater Ordinance by the Naperville City Council, the City required that notice (“**Notice**”) of the proposed Ordinance be given to the owners of the Other Properties (hereinafter “**Owners**”).
6. The names and addresses of the Owners of the Other Properties to whom Notice as described herein was sent are listed on **Attachment #1** attached hereto and made part hereof.
7. The Notice, cumulatively comprised of the following, was sent by me to the Owners as set forth below:
 - a. On June 28, 2019 **Attachment #2**, attached hereto and made part hereof, comprised of a letter and a proposed Groundwater Ordinance was sent to the Owners listed on Exhibit A by UPS overnight delivery.

- b. On July 9, 2019 **Attachment #3**, attached hereto and made part hereof, comprised of a letter and a revised Groundwater Ordinance was sent to the Owners listed on Exhibit A by UPS overnight delivery.
