#### **OVERVIEW**

Mr. Valet Parking LLC is a small service corporation looking to provide first-class valet parking services at the Chicago and Suburbs area. We propose to furnish all labor, supervision, insurance, supplies, and other goods and services necessary to provide valet services in a professional, courteous and cost-effective manner.

Valet operations are to be conducted primarily from the main entryway for the restaurant. Services are to be provided depending on the hours needed per day on Monday to Saturday including all holidays. The key operational challenge will be managing high demand for valet during banquets and conventions, as hundreds of cars must be parked during major events for guests and attendees.

The primary parking facility to be used by the valet contractor is space garage, located at: Upper levels of Central Business parking facility and Van Buren parking facility.

Personnel proposed to perform the services include valet drivers and supervisor.
