Detective Creighton presented an update on tobacco inspections. FY26 round one inspections were completed in mid to late December. Two violations were

issued. One of the violations was issued to a repeat offender establishment.

Liquor Commissioners discussed penalties, fines, and revocation hearing options for repeat offenders. Liquor Commissioner Wehrli stated enforcement has been consistent over the years, but an upward trend in repeat offenses has continued.

Detective Creighton offered a possible solution including a text amendment to the Municipal Code to make the code more stringent for repeat offenders.

Commissioner Chirico said it has been approximately 10 years since fines have been reviewed or updated.

Liquor Commission advised staff to come back with a benchmark study to compare fines related to tobacco and liquor violations.

BACKGROUND:

The City has enacted the Class M liquor license ("M License") for the sale at retail and service of wine and beer at recreational and/or lifestyle amenities facilities. Recreational facilities include an art studio, indoor sports facility, golf course, bowling alley or billiards, having a minimum of ten regulation billiard tables. Lifestyle amenities facilities include beauty shops, hair salons, spas, and personal cosmetic establishments.

For recreational facilities, the M License requires that at least 60% of annual revenue come from non-alcohol sources, limits wine and beer sales to times when the recreational area is open and available for use and imposes an annual fee of \$2,200. The license is capped at thirteen (13), twelve (12) of which have been issued, with one (1) additional application currently in progress.

Taste Buds Kitchen, located at 620 N. River Road, Unit 108, is a culinary-themed recreational facility offering cooking classes, summer camps, birthday parties, and corporate events for children, families, and adults. The concept functions much like an art studio but uses food as the creative medium rather than paint. The business operates as a children's kitchen during the day and transitions to adult programming in the evening.




BACKGROUND:

On December 5, 2024, the Liquor Commission recommended approval of a text amendment to allow Heinen's to serve and sell draft beer and self-service wine for on-premises consumption while customers shop throughout the store. As part of its review, the Liquor Commission also recommended the creation of a new liquor license classification, G2 - Boutique Market, to accommodate the request.

City Council approved the text amendment establishing the G2 - Boutique Market liquor license classification on April 2, 2025.

The G2 - Boutique Market liquor license includes several operational requirements intended to ensure that the license applies only to large, grocery stores. The license requires that the store occupies at least 45,000 square feet and limits alcoholic liquor display space to no more than 8% of the total merchandise footprint. To maintain the primary function of a grocery store, at least 80% of total gross sales must come from groceries. The license also requires a dedicated sales counter for the on-premises sale of beer and cruvinet (self-service) wine, along with submission of a drawing to the Liquor Commissioner identifying the designated service areas. These areas must be continuously monitored by video and supervised by a BASSET-certified employee. The license classification is capped at one unless City Council approves an increase.

Heinen's is now seeking to expand its approved consumption area to include an adjacent outdoor patio. This request would extend the existing on-premises consumption privileges to a defined exterior space.



Alcoholic liquor sold in original packages and intended for off-premises consumption shall not be opened or consumed on the premises.

Effective November 19, 2025, the Illinois Office of the Secretary of State began offering Mobile Identification Cards, "Mobile IDs", allowing Illinois driver's license and state identification card holders to present their Illinois driver's licenses and state identification cards digitally via the digital wallet incorporated into the Apple iPhone or Apple Watch.



ILLINOIS LIQUOR CONTROL COMMISSION

Dear Illinois Liquor Control Commission (ILCC) Licensee:

Please be advised that effective November 19, 2025, the Illinois Office of the Secretary of State (ILSOS) will begin offering Mobile Identification Cards, “Mobile IDs,” which will allow Illinois driver’s license and state identification card holders to present their Illinois driver’s licenses and state identification cards digitally via the digital wallet incorporated into the Apple iPhone or Apple Watch.

Under Illinois law, a Mobile ID is an acceptable form of identification which can be used by an individual to prove that they are twenty-one (21) years of age or older, similar to the use of a physical driver’s license or identification card.

Please note that a customer cannot simply “show” their Mobile ID to a server or clerk. Businesses are required to verify the validity of the Mobile ID before accepting it as proof of age. The easiest way to complete this verification is by using the ILSOS Mobile ID Check App, available for iPhone users through the Apple App Store. This app is provided at no cost to ILCC licensees.

Licensed establishments may also use an ISO 18013-5 compliant reader, though obtaining such equipment may involve additional costs. Verification by any other method does not satisfy the business’ obligation to confirm age prior to an alcohol sale.

For convenience, the Mobile ID Check App can be downloaded directly from the App Store. A list of vendors offering ISO 18013-5 readers is provided below.

While the ILCC does not endorse nor recommend any particular company, product or service referenced herein, the following vendors are among those known to offer ISO 18013-5 reader solutions: Desko, Acuant Store (IDology), MyNextID, Adaptive Recognition, CredenceID, MATTR Global, Veridos, Incode, IDScan.net, E-Seek Inc., and Socket Mobile.
