BACKGROUND:

In June 2018, the Water Utilities issued Bid 18-126, Sanitary Manhole Replacement, seeking a contractor to remove and replace sanitary sewer manholes and associated connections to existing sanitary sewer and services in the Naperville Station neighborhood. This project includes traffic control and temporary pavement patching.

The sanitary manholes to be replaced are approximately 80 to 100 years old. They were rehabilitated approximately 20 years ago and further rehabilitation is no longer possible. Manholes are recommended for full replacement.

Work associated with this bid is required to be completed by October 15, 2018. In addition, the bid includes two, one-year options to extend the contract to replace additional sanitary manholes in 2019 and 2020.

budgeted for WWU06 for sanitary sewer system rehabilitations and replacements projects in CY2018. The requested award is within budget.




*Per Council directive, contingency on construction projects is set at 3% on projects over \$500,000 and 5% on projects under \$500,000.


