

It is my understanding that 5G operates at higher frequencies and requires a more dense network of towers and small cells. The increase of electromagnetic radiation is concerning.

Studies on radiofrequency exposure have raised questions about potential health risks. The unknown long term risks are still unidentified. Over 700 students and staff are spending a large portion of their day at Lincoln Jr High and the proximity to that location is unacceptable without the research behind known short and long term health risks.

A quick google map location-to-location search shows that that corner and the school are only just over 200 meters apart! When I looked for the recommendation for *distance from a 5G cell tower* it was noted:

"A review published in the <u>International Journal of Occupational and Environmental Health</u> found people living **less than 500 meters** from base station antennas had increased adverse neural-behavioral symptoms and cancer in eight of the ten epidemiological studies (Khurana 2010).

How can this location even be a reasonable option to consider?

We are writing to share our concerns regarding the proposed cell phone tower structure at 1301 Clyde Drive in Naperville. We are homeowners who live on the same block as the proposed tower.

While we understand the need for upgraded cellular connectivity in our area, it is concerning that the city would consider building one of the tallest structures in Naperville so close to residential homes, when many other options exist for expanding cellular connectivity.

The water tower at 1301 Clyde is an accepted part of the landscape in our area (and of course a necessary part of local infrastructure.) The water tower was not a factor that concerned us during the purchase of our home. To add a structure taller than the water tower is a drastic change to the landscape which can have a notable impact on the neighborhood and local property value.

Regardless of your view on the safety of long term exposure to RF Radiation, there is no denying that a negative perception of 5G towers exists among a large percentage of the public, and this can affect property values as much (if not more) than the physical presence of the tower.

Will the city also be able to prove that any variance granted for a tower of such height adheres to the same safety standards that the original code was based on?
