Dear Council Members and Staff,

As representatives of the non-profit animal rescue and advocacy groups that serve the Joliet area and its animals, we urge the City of Joliet to immediately move forward and pass the Companion Animal and Consumer Protection Ordinance presented by Safe Pets for Joliet. The ordinance has been on hold since 2015 while awaiting a ruling on a legal challenge to a nearly identical ordinance passed by the City of Chicago. On September 21, 2017, the Seventh Circuit Court of Appeals upheld the ordinance, joining every other Court in the nation that has decided on this type of legislation.

Pet stores claim that they do not contribute to the problems that our groups work to solve. That is simply not true. The stores' "products" DO end up in our shelters after the people who purchase them on a whim at the mall encounter the health and behavioral issues so pervasive in pet store animals. The breeders' "producers" DO end up in our rescues when they're too old or sick to be profitable. And the stores' business practices DO contribute to pet overpopulation and the rise of congenital illnesses by giving poorly bred, intact animals to anyone who can pass a credit check.

We have a very specific and simple agenda: to help the residents of our local communities find a pet to bring into their families, to give our local homeless animals a greater opportunity to find homes, to reduce the euthanasia of healthy and adoptable pets, and to take local action to make a negative impact on the businesses of commercial breeders who neglect and abuse innocent animals.

Our mission is much different than the pet stores, whose agenda is profiting at any cost. A puppy or kitten is merely "inventory." We are confident that you share the agenda of bettering our community and not the agenda of profit.

We respectfully request that you pass the Companion Animal and Consumer Protection Ordinance presented by Safe Pets for Joliet. Thank you for your consideration.
