I was an advisor on the award winning M.S. thesis: "Effect of Various Water Chemistry Factors on Legionella Proliferation and the Premise Plumbing Microbiome Composition" by Caitlin Proctor.

This research should not be used to ban use of plastic as a plumbing material. The factors that contribute to Legionella growth are complicated. The status of plumbing materials in controlling or contributing to Legionella, was recently summarized by a National Academy of Science panel (see attached). Please refer to that review for a state of the art understanding and scientific consensus.



Where is Plastic Piping Systems Allowed?



- States colored in blue allow PEX and CPVC for domestic water distribution.
 That's right, the plumbing codes of every state (including Illinois), in one way or other, allow for the use of PEX and CPVC.
- The International Building Code and International Residential Code, which are models for local codes, both allow PEX and CPVC.
- Section 890 Appendix A, Table A of the Illinois Plumbing Code lists approved materials for Water Distribution Pipe. PEX and CPVC are approved same as Copper.
- **NSF 61** is the recognized testing standard which covers all products with drinking water contact. **PEX** and **CPVC** both carry **NSF 61** approvals.
