I was an advisor on the award winning M.S. thesis: "*Effect of Various Water Chemistry Factors on Legionella Proliferation and the Premise Plumbing Microbiome Composition*" by Caitlin Proctor.

This research should not be used to ban use of plastic as a plumbing material. The factors that contribute to Legionella growth are complicated. The status of plumbing materials in controlling or contributing to Legionella, was recently summarized by a National Academy of Science panel (see attached). Please refer to that review for a state of the art understanding and scientific consensus.

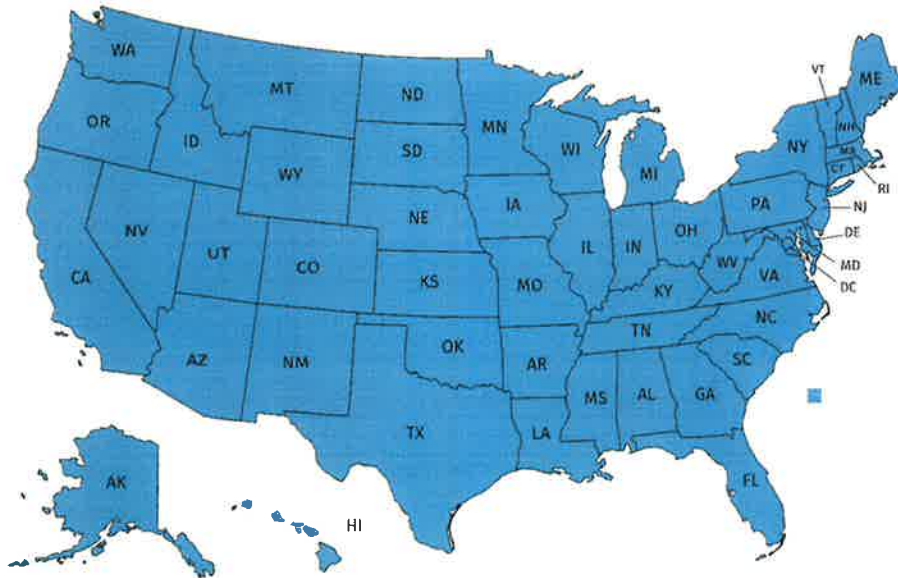
