A:	10-4-17 mirrors the state law requiring pet stores to keep USDA inspection paperwork for two years. The inspection paperwork and the warranty requirements are separate and not related and therefore do not need to have the same timeframe.	Foley, Kristen
	The USDA generates a report after each inspection of a commercial breeding facility. As a general rule, inspections occur at least once a year, however, facilities that are substantially compliant may only be inspected every 18 months. Facilities that have certain violations are re-inspected to ensure compliance, and therefore may have several inspections each year.

	passage of the Good Samaritan law that is moving along in Springfield. Do any parts of this ordinance conflict with that proposed law?	Coyne, Kevin
A:	The City ordinance would not be impacted if SB 2294 were passed. SB 2294 proposes immunity from criminal and civil liability for a person who has a good faith belief that an animal locked in a car is in imminent danger and takes action to remove the animal from the vehicle. This means that the person removing an animal would be able to assert an immunity defense if criminally charged for breaking the car window or sued civilly to recover the cost of the damage. This bill is currently assigned to the Assignments Committee. The City ordinance is designed as a prohibition from keeping animals in cars under certain weather conditions and allows the animal owner to be cited for violating the ordinance. Further, police, animal control officers or other people authorized by law can enter the vehicle to protect the health and safety of the animal.	Foley, Kristen
Q:	Would staff please list communities in Illinois that have passed ordinances that have prohibited the sale of puppies in pet stores unless they are sourced from rescue or shelter organizations. Also please list any successful legal challenges to those passed ordinances.	Anderson, Becky
A:	Chicago, Warrenville, Crest Hill, Waukegan, Cook County and Kankakee County have all banned the sale of puppies from commercial breeders in pet stores. Both the City of Chicago and Cook County ordinance were challenged in federal court and both ordinances were upheld.	Foley, Kristen
