Additionally, based on the many scientific studies and reports that I have read, including those from epidemiologists and CDC, there is no evidence to show that masks are effective in stopping transmission of viruses or influenza. In fact, there is evidence that masks have the potential for doing more harm than good (rebreathing of CO₂, reduce O₂ levels, and other wastes from the lungs). Without firm evidence that masks work, it is a violation of our freedoms and rights to be forced to wear masks that have not been proven to be effective and that can in some cases actually exacerbate existing medical conditions. Randomized Controlled Trial from British Medical Journal 2015 Apr 22;5. A cluster of randomised trial of cloth masks compared with medical masks in healthcare workers. Results: The rates of all infection outcomes were highest in cloth mask arm compared with the medical mask arm. Penetration of cloth masks by particles was almost 97% and medical masks 44%. Conclusion: This is the first RCT of cloth masks, and results caution against the use of cloth masks. Moisture retention, reuse of cloth mask and poor filtration may result in increased risk of infection

Proposed Ordinance on Facial Masking: As a citizen of DuPage county, and an employee in the city of Naperville, I strongly OPPOSE the adoption of an ordinance requiring face masks in all public places. *Face masks are extremely controversial, for every study showing their benefit there is an equal study showing they are not effective at stopping the spread of disease. * This ordinance would not take into

account an individual's own physical or emotional health; both of which can be negatively affected by the wearing of a face mask. * There is currently no scientific proof that a healthy person (asymptomatic) can spread a specific disease. Please give reference to at least ONE study showing this to be true and allow your citizens to make their own INFORMED decision. *The use of the word "cases" is extremely misleading. The PCR test was never intended to be used as a diagnostic tool and is also highly controversial. A positive "case" does NOT equal illness or death. There is no current evidence to suggest that a positive test results in a higher death rate from COVID-19. *A recent study from John Hopkins, conducted using the CDC's own published numbers reveals that when compared to recent years, the overall death rate (from all causes) in the United States HAS NOT CHANGED due to COVID-19. You simply cannot have a "devastating pandemic" and not see an increase in the overall death rate. While I do not want to deny or minimize the tragic death of loved ones, this information suggests that the world is not any more –or less – dangerous than it has been in past years. As someone who has studied and taught health and nutrition for over 20 years, I see this as use of incomplete information and the proposed mask ordinance as a way to instill further FEAR in your citizens and not as a true expression of public health. I have seen Facebook posts that the City Council is considering a new mask-wearing ordinance for the city of Naperville. In drafting and amending any such ordinance, I ask that you take the following into consideration:

As of 11/17, ICU bed availability in DuPage County is shown at the IDPH website as 30%; the figure from Ms. Sullivan's post on Facebook shows overall hospital bed availability at Edward Hospital to be 25%.

Both are still in the green “risk” indicators. However, I could see where Edward Hospital administrators & first responders could be concerned about moving to yellow and red in the winter months.

Has the City Council discussed whether the mask ordinance will apply only to the densely populated downtown area (bordered approximately by Webster, Van Buren, Washington, and Aurora)? Or is the Council considering an ordinance that will apply citywide - including to low population density individual subdivisions, walking trails, and parks, where masks are less essential to public health & safety?

It is important to tailor any ordinance to something that would be meaningful to controlling COVID spread as well as worthwhile to enforce. Any ordinance extending beyond the busy Naperville downtown area may come across as a pretext for a new citation-based revenue stream, where citations in 2020 are generally down due to decreased traffic everywhere. It also could lead to less-than-neighborly communications between neighbors which helps no one.

It is also important to provide a timeline for how long the ordinance will be in effect. Even if people may be willing to comply - and need to comply - now, there may be a lot more pushback if the ordinance is still in effect in June.

I oppose the City of Naperville from passing both Option 1 and 2 for mandated wearing of masks in public. It is contrary to peer-reviewed research. My private practice in Environmental Health & Illness, and collaboration with physicians in Manhattan, NY, Chicago/ Champaign, IL, and Cleveland, Ohio has shown us the multiple peer-reviewed studies over 40 yrs. where the efficacy of masks for viruses is not supported-they catches 'droplets' but do not to filter submicron viruses. The US Dept. of Labor states: "Cloth Face Coverings" , "Surgical Masks" -"Are not considered PPE...Will not protect the wearer against airborne transmissible infectious agents due to loose fit and lack of seal or inadequate filtration". The New England Journal of Medicine (5/21/20) states: "We know wearing a mask outside of a healthcare facility offers little, if any, protection for infection..The chance of catching COVID 19 from passing interaction in a public space is therefore minimal." Viral particles (COVID-19) are 0.1 microns in size, a N95 filters 0.3 microns and larger at best without a loose fit/gaps around edges. British Medical Journal research (2015, MacIntyre et al) clearly shows, "The rates of all infection outcomes were highest in the cloth mask arm, with the rate of ILI (influenza like illness) statistically higher..."Moisture retention, reuse of cloth masks and poor filtration may result in increased risk of infection." Research with surgeons (2008, Beder et al) shows wearing a mask decreases oxygen levels and the resulting hypoxemia/ increased carbon dioxide, downregulates genes linked to immune responses (Casalino-Martsuda et al, 2018). The consequences of masks to our health are serious when considering it is known coronaviruses infect the brain through the olfactory (nose) and trigeminal nerves (Perlman et al,1989) and COVID-19 is being found in the brain and cerebrospinal fluid causing neurological diseases (Wu, et al,July 2020). Research for dentists in 2016, again shows masks do not filter viruses or submicron particles, which pass through them. (Oral Health Journal 10/18/16), Stacionian, Genevieve Briand, from Johns Hopkins, shows that "even patients dying

from other underlying diseases but are infected with COVID-19 count as COVID-19 deaths. This is likely the main explanation as to why COVID-19 deaths drastically increased while deaths by all other diseases experienced a significant decrease.” (American Institute for Economic Research 11/26/20) Our democracy- upon which our civil liberties rest, -dictates masks be a personal choice, not mandated, especially with little peer-reviewed science over 40 yrs to substantiate their ability to stop a submicron virus. Thank you.

Agenda item 20-1415 wearing protective face coverings in public. I oppose both options for this agenda item. In a Danish study published on November 18th by the American College of Physicians in the Annals of Internal Medicine it was concluded that "the recommendation to wear surgical masks to supplement other public health measures did not reduce the SARS-CoV-2 infection rate among wearers". This study used surgical grade masks and provided proper fitment instructions. If surgical grade masks do not provide protection when worn properly it is highly unlikely that lesser grade masks will provide protection. Other studies have shown that cloth masks have a 50-60% efficiency at filtering particles that are 1 micron in size. Covid particles are approximately one tenth of that size which clearly reduces cloth masking effectiveness on any inhalation or exhalation that passes through mask material, however there is no filtering impact to the air that is moved around, over, or under any mask. Additionally, The Wall Street Journal published an article on November 11th showing that the case for mask mandates relies on bad data. The result of masking mandates is then to provide a false sense of security that there is safety related to mask wearing. This false sense of security can and is luring at risk people to resume normal activity and specifically gather more closely together with others. It is poor public policy to encourage at risk people to unknowingly expose themselves to a situation that is riskier for them by creating a false sense of security through mask mandates.
