BACKGROUND:

The Department of Public Utilities – Water (DPU-W) issued Bid 16-216 seeking contractors to install guardrails with hot-mix asphalt shoulder widening at twelve locations along the south side of 75th Street, between Modaff Road and Naper Boulevard. This work also includes the maintenance and temporary timing of the traffic signals at Modaff Road, Olympus Drive, Washington Street and Naper Boulevard as well as the relocation of conduit and fiber optic, curb and gutter replacement and landscape restoration.

These guardrails are being installed to protect vehicles traveling eastbound on 75th Street from impacting the Department of Public Utilities – Electric (DPU-E) monopoles located on the south

side of the roadway. This project was originally advertised and bid in January/February 2015; however since the bids were not within budget and deemed unacceptably high in cost, the bids were rejected (Low Bid: \$755,765.29). Subsequently, DPU-W redesigned the project to simplify certain elements of work, lower the overall cost and bring the project closer to the DPU-E budget amount.

BID TABULATION

The following bids were received:

Alliance Contractors, Inc.	\$462,409.17
Engineer's Estimate	\$539,869.00

The cost of the project is 33.9% lower than the Engineer's Estimate. The estimate in part was based on the previous bids received in February 2015. The current bidding climate appears to be much more favorable than last year, as the unit pricing contained in this bid is approximately 40% lower than the previous February 2015 bid. Changes to project scope and a more flexible construction schedule may have also helped to attract bids that are substantially lower than anticipated.

Staff believes that the low bid submitted is reasonable for performing the work as specified. City staff has experience with D Construction, Inc. and has found them to be a capable contractor on related projects.

FISCAL IMPACT:

The 75th Street Guardrail Installation is expensed to the Capital Improvement Program line below. The project is related to EU12, Electrical Systems Relocations, for which \$1,450,000 has been budgeted in CY2016. The award amount of \$357,060.25 is within the budgeted amount for this expense.
