## ORDINANCE NO. 17 -

AN ORDINANCE AMENDING ORDINANCE 05-179 (AN ORDINANCE AMENDING THE ZONING ORDINANCE FOR THE PROPERTY LOCATED WEST OF PLAINFIELD-NAPERVILLE ROAD NORTH OF SARATOGA ROAD AND SOUTH OF HAMLET)

FOR THE TRAMORE DEVELOPMENT

WHEREAS, K. Hovnanian T&C Homes at Illinois ("Petitioner"), has petitioned the City of Naperville for an amendment to Ordinance 05-179 in order to remove the attached building elevations for the approximately 5.4 acre property located west of Plainfield-Naperville Road, north of Saratoga Road, south of Hamlet Road, and legally described in **Exhibit A** and depicted on **Exhibit B**, commonly known as Tramore Subdivision ("Subject Property"); and

WHEREAS, the owner of the Subject Property is Turning Pointe Autism Foundation; and

WHEREAS, on September 20, 2005, the City Council of the City of Naperville passed Ordinance 05-179, Amending the Zoning Ordinance of the City of Naperville, Illinois for the Subject Property located west of Plainfield-Naperville Road, north of Saratoga Road and south of Hamlet Road, and

**WHEREAS**, Ordinance 05-179 also approved a preliminary plat of subdivision that created 16 duplex lots and approved architectural elevations for the duplexes; and

**WHEREAS**, the petitioner is requesting to amend Ordinance 05-179 to remove the attached building elevations such that they are no longer the controlling elevations for the Subject Property; and

**WHEREAS**, upon removal, the Petitioner will have the ability to propose new building elevations reflective of the intended design of the units; and

**WHEREAS,** on June 7, 2017, the Planning and Zoning Commission considered the Petitioner's request and recommended approval of PZC 17-1-038; and

**WHEREAS**, the City Council has determined that the Petitioner's request should be granted as provided herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule powers, as follows:

**SECTION 1**: The foregoing recitals are incorporated as though fully set forth here.

All exhibits referenced in this Ordinance shall be deemed incorporated and made part hereof.

**SECTION 2**: The building elevations attached to Ordinance 05-179 are hereby removed.

**SECTION 3**: All other approvals set forth in Ordinance 05-179 shall remain in full force and effect.

**SECTION 4**: This Ordinance is subject to all conditions and requirements set forth in the Naperville Municipal Code, as amended from time to time.
