#### **BACKGROUND:**

This project is located on the south side of Ogden Avenue between Columbia Street and Wisconsin Street. This is Phase II of a larger project designed to provide circulation loops at several water main dead-ends, allow for interconnection between pressure zones, ensure water quality and incorporate the south side of Ogden Avenue, between Columbia and Wisconsin into an enhanced pressure zone of the distribution system to increase water pressure and enhance fire flow. This project was one of the recommended improvements from DPU-W's 2010 Water Distribution System Hydraulic Study.

In addition, the water mains along the north and south sides of Ogden Avenue from Colombia Street to East Avenue have experienced a number of water main breaks. Water main breaks disrupt utility service to the commercial businesses, affect traffic on Ogden Avenue creating long delays and interrupt commerce. DPU-W is planning to replace additional sections of the water main along Ogden Avenue in future years.

Bidders were required to submit two (2) bid responses for this project, summarized as follows:

- BASE BID Includes water main replacement on the south side of Ogden Avenue from Columbia Street to Wisconsin Street.
- ALTERNATE "A" Includes all work in the Base Bid plus the installation of a 2-way electrical duct bank within the above mentioned project limits. This duct bank would have been utilized by DPU-E at a later date.

After evaluating the bids, DPU-E decided to forego the duct bank work included in Alternate "A" because the anticipated savings of a joint project with the water main was not realized. A greater savings could be realized by having the work performed under existing DPU-E contracts. The elimination of Alternate "A" allowed DPU-W to evaluate and recommend the award of the Base Bid from the lowest responsive, responsible bidder.

The cost of the project contained in the Base Bid is 33.1% lower than the engineer's estimate. Past bids of similar work were used in creating the engineer's estimate. Current bidding climate appears to be more favorable than in recent past as the subject project received unit pricing on

several bid items less than bid prices previously received, especially on the following two items: Last year, the unit cost for the 12" Water Main was \$225.00 per foot (engineer's estimate used \$210 per foot). The unit price submitted is substantially lower at \$95.00 per foot, which creates an overall savings of \$166,000 on this single item. Additionally, the recent bid saw a significant reduction in the unit price for Traffic Control, Mobilization and Water Main Connections resulting in an overall savings of \$98,000 between the estimate and low bid. These items alone contribute \$264,000 to the overall difference of \$343,000. The lower overall bid prices suggests a more competitive bidding environment in 2016.

Staff believes that the low bid submitted is reasonable for performing the work as specified. DPU-W has previous experience with Martam Construction on the Route 59 project and has found them to be a capable contractor on similar projects.

The Ogden Avenue Water Main Replacement is expensed to the Capital Improvement Program line below. A total of \$1,300,000 is budgeted for WU04, Water Distribution System – Rehabilitation/Replacements, in CY2016. This water main replacement is the primary component of WU04 for CY2016.
