BACKGROUND:

This contract is for a Microsoft Enterprise Agreement (EA) that provides licensing for all Microsoft software products utilized by the City. The third three-year extension to the Microsoft Office Enterprise agreement was approved by the City Council on December 16, 2014; the extension ends on December 31, 2017.

The IT Department wishes to procure additional Microsoft Internet-based services ("Azure Cloud Services") to increase reliability and decrease complexity of the cost of City IT services. This initial purchase will allow services to be moved to the Azure Cloud in a structured, measurable fashion to ensure success and proper ROI for future purchases. Microsoft requires that these services be procured as an "Azure commitment level" and attached to any existing Microsoft Enterprise Agreement.

DISCUSSION:

This change order is requested for the purchase of Microsoft Azure Cloud Services to provide for introductory data center services. Relocating specific applications and data to cloud services will allow the city to reduce capital expenditures by reducing needed hardware and software that was to be procured as part of CIP # CE149, Virtual Server and Storage Area Network Upgrade. The CIP project was intended to upgrade the City's existing virtual host servers and enterprise storage area network (SAN) to allow it to support the increasing number of applications and amount of data being utilized within the City's data centers. By leveraging Azure Cloud Services for many of the City's storage and computer needs, the City will be able to scale network resources on an as needed basis, ensure high availability and offload the backend management and disaster recovery services which will further reduce operating and capital expenses. Azure Cloud Services are procured on an annual basis with any overages billed quarterly in a "true up" process and costs will be presented to Council in the form of a future change order dependent on usage for the term of the contract.

The City's Microsoft Enterprise Agreement is expensed to the IT's Technical Services – Support Services account. A total of \$360,000 was budgeted in CY2016 for the Microsoft Enterprise License Agreement within the account listed below. This change order will increase the total CY2016 expense to \$385,000 in the operating budget. Utilizing Azure Cloud services versus purchasing storage area network upgrades through CIP project #CE149 will result in decreased capital spending for CY2016. Both future year capital and operating budgets will be appropriately adjusted to reflect capital savings and the increased operating expense.

BACKGROUND:

This award will provide for a third three-year extension of Contract 06-106, Microsoft Enterprise Agreement- Component Level D, with CDW-G for Microsoft volume software licensing, merge the agreements between Microsoft and the City of Naperville and the Department of Public Utilities-Electric. In December 2005 as approved by Council on 11/01/05 – Agenda Item H, the City entered into an Enterprise Agreement (EA) contract with Microsoft and CDW-G for the licensing of Microsoft software. Council approved two additional three-year extensions to the contract (approved by Council on 1/15/08 and 1/14/11). The City utilizes the contract between Microsoft and the State of Illinois, executed through CDW-G. The agreement with the State and CDW-G is based on the collective purchasing volume of Microsoft software by every State agency and local governments that have chosen to participate within the State. Council approved the City's participation at Component Level D, which provided the ability to purchase Microsoft software licensing on an as-needed basis. The agreement required a minimum three year commitment, with the license cost amortized over the three year term, and included software upgrade and price protection. Each year the City reviews the number of existing licenses and adds any increase through a "true-up" process.

Historically, the City subscribed for Microsoft software licenses through the use of three (3) separate and diverse agreements:

- 1. Enterprise Agreement
- 2. IT Software Assurance Agreement
- 3. Electric Utility Software Assure Agreement

This results in duplicate licensing and more complicated management and tracking of software licenses. With this Agenda item, the three "agreements" are combined into one. CDW-G, the State of Illinois collective purchaser and supplier of Microsoft licensing, will:

- Continue to treat each agreement as separate until their end of term
- Issue credits equal to amounts paid by the City towards the yearly Enterprise Agreement cost

DISCUSSION:

This contract, allows for a three year extension of the Microsoft Enterprise Agreement, providing continuing software maintenance and upgrade protection of existing licenses for client operating systems, client applications, server operating systems and server applications, as well as Office and Microsoft related planning. Additionally, during the enrollment extension period, the City is able to upgrade the current Office Suite via Office 365. As announced by Microsoft, the firm is moving from per user licensing to a per device licensing during the next few years.

The recommended award will allow the City to save an estimated \$64,000+ per year by providing software resources in both desktop and mobile environments; plus, reduce the overall number of client licenses as we move forward with the Office 365 implementation. It should be noted that Microsoft allows Enterprise Agreements for government related entities within a State to be purchased only through one partner (State of Illinois partner: CDW-G). The State contract

is awarded by competitive bidding. City IT staff worked diligently to ensure that only needed Microsoft products are included within the new Enterprise Agreement. Most of the yearly savings are the result of this effort. IT's efforts are backed by our consulting firm, the Planet. Their assessment findings showed similar savings per year.

BACKGROUND:

The purpose of this award is to extend contract 06-106 with CDW-G for Microsoft client and server software for an additional three years. The city entered into a three-year Enterprise Agreement (EA) contract with CDW-G for the licensing of Microsoft software in December 2005 (approved by Council on 11/01/05 – Agenda Item H-3b). The City utilized the state of Illinois contract with CDW-G for the purchase of these products. The enterprise agreement for the state of Illinois is based on the collective purchase volume of Microsoft software by every state agency and local government within the state. Council approved the City's participation at Component Level D, which provided the ability to purchase licensing for Microsoft Office suite applications including Microsoft Word, Excel, PowerPoint and Access, server licensing and other ancillary products on an as-needed basis. The agreement required a minimum three year commitment, with the license cost amortized over the three-year term, and included upgrade and price protection. Council approved a three-year extension of the original agreement, providing continuing software maintenance and upgrade protection for the licensed software at the December 16, 2008 meeting – Agenda Item I6.

DISCUSSION:

This contract allows for a second three-year term extension of the original agreement; providing continuing software maintenance and upgrade protection on the licensed software. The agreement also continues the provision for Component Level D pricing for additional software product licenses and Microsoft support benefits. The licensing cost for the original software components was fulfilled during years 1-3, software maintenance costs continue through years 4-9.

During the current renewal process, additional product licensing will be added to the contract and amortized over the three-year term. Licensing and software maintenance was included in the seventh year renewal for:

- Windows 7 licenses to allow for all City desktop PCs and laptops to be upgraded to the latest, most secure Windows operating system.
- Virtual Desktop Access licenses to allow for the use of thin clients as a lower cost option to desktop PCs

The alternative option to continuing the Microsoft Enterprise Agreement is the use of the Microsoft Select Agreement. With this option the City would need to repurchase a full license for each Microsoft Office Suite application and Windows Server in order to upgrade. The cost for this approach would be \$745,607 and the license purchase would be a single payment and not amortized over the term of the contract. As a result, the Microsoft Enterprise Agreement continues to be the lowest cost option for the City.

Following are the projected costs for the three-year contract extension. Funds exist in the IT budget to cover the unbudgeted costs for FY 12 and FY13.





DESCRIPTION

The city entered into a three-year Enterprise Agreement (EA) contract with Microsoft and CDW-G for the licensing of Microsoft Office and Microsoft server software in December, 2005 (Agenda Item H-3b) In July 2005, CDW-G was awarded the Microsoft Enterprise Agreement Contract for the State of Illinois The city utilized the State of Illinois Joint Purchasing Contract for the purchase of these products. Council approved the city's participation at Component Level D, which provided the ability to purchase licensing for Microsoft Office suite applications including Microsoft Word, Excel, Power Point, Access, server licensing and other ancillary products on a line-item, ala carte basis. The agreement required a three-year commitment, with total costs spread over the three year life of the contract, and also includes upgrade and price protection for additional licenses purchased. The second year of the contract was approved by Council 12/19/06 (Agenda Item H-3a).

The total cost to the City for the three years was estimated to be \$583,862. The third year was estimated to cost \$203,169.00. The actual cost of the third year of the commitment is \$202,034.03. The purchase of additional server licensing, Microsoft Visio and Project Office applications during the third year option is \$7,741.76, for a total cost of \$209,775.79.







DESCRIPTION

The purpose of this award is to recommend that the city enter into a three-year Enterprise Agreement (EA) contract with Microsoft and CDW-G for the licensing of Microsoft Office and Microsoft server software. The Microsoft EA includes licensing of Microsoft Office suite including Microsoft Word, Excel, Power Point, and Access, server licensing and other ancillary products. We are recommending that the city use the State of Illinois contract for the purchase of these products. In July 2005, CDW-G was awarded the Microsoft Enterprise Agreement contract for the State of Illinois

With the EA, Microsoft is offering the city an even lower cost to sign another three-year EA at the end of the first term, at much lower prices than the first three years. As the table indicates, the Select Agreement Only option is the lowest three-year cost. However, the IT Department does not see any alternatives to using Microsoft Office for at least the next six years and recommends that we take the lowest six-year cost.


In 1999, the city purchased Microsoft Office 2000 software under the Select Agreement and has used that software for the past six years. The cost of the purchase was \$169,939 60. Even though we have used the same version for six years, we do not recommend using the same version for that long as a standard or best practice. In fact, the main reason for extending the use that long is because Microsoft has changed their licensing programs several times over the past few years, and there was not a clear way for us to proceed until now. Also, since the IT Department is recommending that we upgrade at least two times during the six-year period, it makes financial sense to take the lowest six-year cost.

We are now at a point where the software must be upgraded in order to remain eligible for support from Microsoft, meet new business needs, and stay compatible with associated computer hardware and software. In the past, the city has procured this software on an individual one-time basis using the Microsoft Select Agreement through the State of Illinois contract. Microsoft has offered the EA to larger customers for many years, however, this is the first time there has been a statewide vehicle in place to allow local governmental organizations to take advantage of the EA at volume prices

The EA for the State of Illinois is based on the collective purchase volume of Microsoft software by every state agency, and local government within the State. While this has been true for Microsoft's Select Agreement contracts, Microsoft has not offered the EA to state and local governments until July 2005. The pricing and discounts for the current EA were selected by the State of Illinois based on a Request For Proposals response from CDW-G based on volumes between 50,000 and 100,000 users. This new statewide EA contract vehicle currently offers the best pricing to local government over any other contract options available to the City of Naperville. Municipalities including Peoria, Bloomington, Evanston, Kane County and Lake County have recently approved using the EA through the State.

The State of Illinois was in the process of negotiating a five-year EA with Microsoft at the time the IT Department was preparing the FY 05-06 budget. Based on preliminary information from Microsoft, staff budgeted for the licenses based upon a five-year agreement that would have lowered the annual cost by amortizing the cost of licenses over the length of the agreement. The budgeted amount is \$125,000, for the first year, however, we did not know what the costs were to be for years two through five. Ultimately, the State of Illinois decided to award a three-year agreement to CDW-G, which is where we are today.










In order to meet our budgetary needs, the city negotiated a \$43,620 credit for Microsoft Sharepoint Intranet Portal software that effectively lowers our first year cost to \$125,000, the budgeted amount. Please note that the cost for years two and three of the EA are higher than year one because they cover the balance of the total cost.

The advantages of purchasing software using the Microsoft Enterprise Agreement-Component Level D are as follows.

- The cost of the software licenses is amortized, without interest, over a three-year period instead of paid entirely the year it is purchased
- The method of making annual one-time payments under the EA significantly reduces administrative costs involved with purchasing the licenses individually
- The EA allows staff to use the latest versions of Microsoft software as they become available during the lifetime of the agreement
- The EA sets fixed costs over a three-year term at the start of the agreement
- The six-year cost of software included in the EA is 15% less expensive than any other option available to the city. The EA also includes annual volume discounts based upon the number of public agencies who have signed on to the State of Illinois EA. These volume discounts are estimated to be 2.40% after the first year, 9% after the second year, 13.20% after the third year. If the city renews after year three, the volume discounts are estimated to be 17.76% annually and the city pays only 35% of the original cost (years one, two & three) during years four, five and six
- The Home Use Program allows city staff covered in the agreement (Licensed Office Users), to purchase a "home use" license of Microsoft Office Professional for approximately \$20
- The Employee Purchase Program provides the opportunity to City staff covered in the agreement (Licensed Users) to purchase other Microsoft software discounted up to 30% off the standard retail price
- The EA provides access to resources that help keep the city computer systems
 running smoothly These resources include 20 days of technical training vouchers
 worth \$7,000, one day of desktop deployment planning worth \$1,000, \$30,000 of
 consulting and implementation services, and upgraded access to technical support
 via the web, telephone and documentation
- The EA provides IT staff with simplified license tracking
- If the City decides to end the agreement before the three-year term expires, the
 City is responsible to pay the balance of the cost of the software licenses it
 purchased under the program Microsoft would convert Enterprise Agreement
 licenses to Select Agreement licenses based upon straight proration of the amount
 the city had contributed

The City entered into a three-year Enterprise Agreement (EA) contract with Microsoft and CDW-G for the licensing of Microsoft Office and Microsoft server software in December 2005 (Approved by Council 11/01/05 - Agenda Item H-3b). In July of 2005, CDW-G had been awarded the Microsoft Enterprise Agreement contract for the State of Illinois The City utilized the State of Illinois contract for the purchase of these products. Council approved the City's participation at Component Level D, which provided the ability to purchase licensing for Microsoft Office suite applications including Microsoft Word, Excel, Power Point, and Access, server licensing and other ancillary products on a line-item, a la carte basis (see Original Agenda Item attached as Exhibit A).

The agreement required a three-year commitment, with total cost spread over the three-year life of the contract, and includes upgrade and price protection for additional licenses purchased. The cost to the City for the three years was estimated to be \$583,862. Year two was budgeted for \$215,000

Staff requests that Council approve year two of the three-year Microsoft Enterprise Agreement-Component Level D option with Microsoft and CDW-G, at the second year cost of \$214,755
