Mr. Mayor and Council and Staff,

Last week several of us who are part of the South Homeowners of Wheatland group had put together a survey to get feedback from the community on what they thought of the city changing the ordinances to allow a car service in the Naperville Crossings complex.

We put together a simple two-question poll about the Christian Brothers service center coming into Naperville Crossings. We publicized it to the surrounding subdivisions to get their thoughts and feelings about changing the PUD for Naperville Crossings.

This survey is very credible, as you'll notice when you click "individual responses" on the report you can see the IP Address of the respondents. Only one IP (or computer) can take the survey at a time. Thus, no one can manipulate the survey. Plus, I'm happy to show you the thread of comments on Facebook that coincide with the comments you'll read in the results.

The survey was pushed out on the Tall Grass Facebook page (876 members) and to the Heatherstone nearby subdivision. In addition, some people may have sent it to neighbors and friends in other surrounding areas.

Many of us in the community have heard "we have to fill Naperville Crossings, so we'll have to allow a change of zoning to do it." However, the case has been that over time the right users show up. And I think vacant stores and vacant land are part of the real estate business. A risk that they take on.

I was dismayed to hear that City Staff "was in support" of the change. I thought they should provide the facts. And the plan commission is to focus on "zoning" issues, and issues related to the building codes, etc... yet, I heard the plan commission and the staff trying to justify the need for this change not for the community, but trying to sell everyone on the need to approve something that no one on the community wants. I see a benefit to the car service group. I see a benefit to the owners of the property. And I guess I see a benefit to the tax rolls. Yet, I think it's a nominal impact on taxes vs. the desire of the community to keep with the plan set forth for Crossings.

As I have maintained in the past, and as of now, I think highly of Marcy and Bill and the team at the city. And I think we have a good city council and mayor. I have shared this with my neighbors and friends who know I get active sometimes. And I informed our neighbors and the community that the issue will go in front of the council.
