

Planning, Design, and Construction Committee

Meeting Minutes

A. CALL TO ORDER:

Chairman Buddingh called the May 1, 2018 Naperville Riverwalk Planning, Design & Construction Committee meeting to order at 7:30 a.m. The meeting was held in Conference Room 164 of the Naperville Municipal Center located at 400 S. Eagle Street, Naperville, Illinois.

C. PUBLIC FORUM:

No members of the public were present to address the committee.

D. OLD BUSINESS:

2. Park District – Chuck Papanos

Asset Management Plan (AMP)

Following yesterday's annual AMP walk, Papanos stated that he will bring a list of assets and the related photographs, that fall within the fair and poor range, to the June PDC meeting. He also questioned whether it is appropriate to include the large overstory on the AMP. The large trees are the only landscape assets that are currently included. The consensus was to eliminate them from future lists while noting that the trees are constantly monitored with any issues addressed annually.

- Moser Tower Assessment Bill Novack/Brian Dusak
 Dusak reported that all field work has been completed. The samples are
 currently being analyzed. Additional information will be available and presented
 at the June PDC meeting.
- Naperville Jaycees Park formerly Smart Park Geoff Roehll
 The City Council approved the concept design for the Naperville Jaycees Park
 at the April 17, 2018 meeting. The May 1, 2018 agenda includes the request

for approval of the \$120,000 line of credit. If approved, the next steps will be to begin the engineering drawings and submit a stormwater permit application to DuPage County. The Riverwalk Foundation has received the first payment from the Naperville Jaycees.

5. Harmony Park – Geoff Roehll

Roehll reported that the Park District is scheduled to vote on the addition of Harmony Park to the Riverwalk at their April 24, 2018 meeting. The same request is scheduled to be presented to the City Council at their June 19, 2018 meeting. If the park is approved, the construction drawings will be submitted to the City's review team. Roehll also mentioned that there is a possibility that a portion of the construction cost may be donated by a contractor. Century Walk/Rotary Club have agreed to reimburse the City for the first five years of maintenance of the park.

 Papanos reported that the Park District will pressure wash and seal the labyrinth in the next couple of weeks.

Roehll commented that a portion of the Riverwalk will likely be impacted with the upcoming reconstruction of the Washington Street Bridge. He said that it may provide an opportunity to address the area between the north side of the river and Chicago Avenue. Also mentioned was the possible replacement of the timber wall on the south side of the river near J.C. Licht.

E. NEW BUSINESS:

Riverwalk Maintenance Intergovernmental Agreement Novack reported that the Riverwalk maintenance agree

Novack reported that the Riverwalk maintenance agreement with the City and Park District will expire on December 31, 2018. Talks to amend the agreement are ahead of schedule as both parties have been meeting to discuss the updates. A couple of changes to note include the term of the agreement (3-year term with two 1-year extensions), and the addition of Harmony Park.

The intention is to seek City Council approval for both the Harmony Park and amended agreement in July.
