## ORDINANCE NO. 18-

## AN ORDINANCE GRANTING A VARIANCE TO SECTION 6-2-12:1 (FENCES: RESIDENCE DISTRICTS) FOR THE FENCE AT 2609 SPRINGDALE CIRCLE

WHEREAS, Paul O'Neill ("Petitioner") has petitioned the City of Naperville for approval of a variance in order to construct a fence in the corner side yard on the subject property located at 2609 Springdale Circle, Naperville, IL, which is legally described in <a href="Exhibit A">Exhibit A</a> and depicted on <a href="Exhibit B">Exhibit B</a> ("Subject Property"); and

WHEREAS, the Subject Property is zoned R1A (Low Density Single-Family Residence District) and is located within the Brook Crossings Unit 1A subdivision; and

WHEREAS, Municipal Code Section 6-2-12:1.2 (Fences) allows an open style fence up to 4' in height in the required corner side yard; and

**WHEREAS**, the Petitioner wishes to construct a 6' tall, solid style fence in the required corner side yard on the Subject Property as depicted on **Exhibit B**; and

WHEREAS, on May 16, 2018, the Planning and Zoning Commission conducted a public hearing to consider the Petitioner's request for the Subject Property and recommended approval of the request; and

WHEREAS, the City Council of the City of Naperville has determined that the Petitioner's request meets the variance standards as provided in **Exhibit C** attached hereto and should be granted as provided herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule powers, as follows:

**SECTION 1:** The foregoing recitals are incorporated herein as though fully set forth in this Section 1. All Exhibits referenced in this Ordinance shall be deemed incorporated and made part hereof.

**SECTION 2:** A variance to permit a 6' tall solid style fence in the required corner side yard, as depicted on the Plat of Survey attached to this Ordinance as **Exhibit B**, is hereby approved.

**SECTION 3:** The City Clerk is directed to record this Ordinance and its exhibits with the Will County Recorder at the direction of the City Attorney.

**SECTION 4:** This Ordinance shall be in full force and effect upon its recordation with the Will County Recorder.
