## ORDINANCE NO. 18 - \_\_\_\_

## AN ORDINANCE APPROVING THE PRELIMINARY/FINAL PLAT OF SUBDIVISION FOR NAPERVILLE IPT SUBDIVISION

WHEREAS, IPT Naperville DC LLC ("Petitioner"), has petitioned the City of Naperville for approval of a preliminary/final plat of subdivision for the 21.622 acre property generally located south of North Aurora Road, north of the Burlington Northern & Santa Fe Railroad and east of the Canadian National Railway, legally described on <a href="Exhibit A">Exhibit B</a> ("Subject Property"); and

WHEREAS, the owner of the Subject Property is the City of Naperville ("Owner"); and

WHEREAS, the Petitioner and Owner will enter into a purchase and sale agreement to transfer ownership of 8.2 acres of the Subject Property from the Owner to the Petitioner; and

SECTION 2: Subject to the terms and conditions set forth and referenced herein, and subject to adoption of a Resolution Approving an Easement Agreement between the City of Naperville and IPT Naperville DC LLC, and adoption of a Resolution Approving an Purchase and Sale Agreement between the City of Naperville and IPT Naperville DC LLC for Property Located at 540 Frontenac Court, the Preliminary/Final Plat of Subdivision for Naperville IPT Subdivision, attached hereto as <a href="Exhibit B">Exhibit B</a>, and the Owner's Acknowledgement and Acceptance Agreement attached hereto as <a href="Exhibit C">Exhibit C</a>, are hereby approved. The City Manager is hereby authorized to sign, and the City Clerk to attest, said Preliminary/Final Plat of Subdivision for Naperville IPT Subdivision and said Owner's Acknowledgement and Acceptance Agreement.

<u>SECTION 3</u>: The Preliminary/Final Plat of Subdivision for Naperville IPT Subdivision, attached hereto as <u>Exhibit B</u> and the Owner's Acknowledgement and

Acceptance Agreement attached to this Ordinance as **Exhibit C** shall be effective upon their recordation with the DuPage County Recorder

**SECTION 4**: This Ordinance shall be in full force and effect from and after its passage and approval.
