ORDINANCE NO. 18 -

AN ORDINANCE AUTHORIZING THE EXECUTION OF AN ANNEXATION AGREEMENT FOR THE PROPERTY LOCATED AT 11007 S. BOOK ROAD (ENCLAVE ON BOOK)

WHEREAS, Zion Evangelical Lutheran Church ("Owner") is the owner of the real property located on the east side of Book Road, north of Hassert Boulevard (Enclave on Book) legally described as Parcel A on <u>Exhibit A</u> and JHL Developments LLC ("Owner") is the owner of the real property legally described as Parcel B on <u>Exhibit A</u>, collectively referred to as the subject property depicted on **Exhibit B** ("Subject Property"); and

WHEREAS, JHL Developments LLC ("Petitioner") has filed a petition for annexation of the Subject Property into the City of Naperville ("City"); and

WHEREAS, the Petitioner is ready, willing, and able to enter into an annexation agreement and to perform the obligations required herein and as set forth in the Naperville Municipal Code ("Code"), as amended from time to time; and

WHEREAS, in addition to seeking approval of the Annexation Agreement provided for herein, Petitioner has also requested City approval of ordinances approving annexation, rezoning, a preliminary/final plat of subdivision, and variance to the interior side yard setback requirements on the Subject Property; and

WHEREAS, the Petitioner and the City of Naperville have fully complied with the statutory and Code provisions required for the approval and execution of an annexation agreement; and

WHEREAS, the City Council of the City of Naperville has determined that it is in the best interests of the City of Naperville to enter into the Annexation Agreement attached hereto as Exhibit C.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority, as follows:

SECTION 1: The foregoing recitals are incorporated as though fully set forth here.

All exhibits referenced in this Ordinance shall be deemed incorporated and made part hereof.

SECTION 2: The Mayor is authorized and directed to execute, and the City Clerk is authorized and directed to attest, the Annexation Agreement for Enclave on Book attached hereto as **Exhibit C**.

SECTION 2: The City Clerk is authorized and directed to record this Ordinance and the Annexation Agreement for Enclave on Book, and its exhibits, with the Will County Recorder upon completed execution thereof.

SECTION 3: If any section, paragraph, or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, or provision, shall not affect any of the remaining provisions of this Ordinance or any other City ordinance, resolution, or provision of the Naperville Municipal Code.

SECTION 4: This Ordinance shall be in full force and effect upon its passage and approval.
