

**ORDINANCE NO. 18-\_\_\_\_\_**

**AN ORDINANCE AMENDING TITLE 3 (BUSINESS AND LICENSE REGULATIONS),  
CHAPTER 3 (LIQUOR AND TOBACCO CONTROL), AND  
SECTION 11 (LIQUOR LICENSE AND PERMIT CLASSIFICATIONS)  
OF THE NAPERVILLE MUNICIPAL CODE**

**BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule powers that:**

**SECTION 1:** Title 3 (Business and License Regulations), Chapter 3 (Liquor and Tobacco Control), Section 11 (Liquor License and Permit Classifications) of the Naperville Municipal Code is hereby amended by adding the underlined language and deleting the stricken language as follows:

**3-3-11: LIQUOR LICENSE AND PERMIT CLASSIFICATIONS:**

The following are classes of liquor licenses and permits with an annual license and permit fee as indicated:

1. On-premises consumption liquor licenses:

**Class A – Restaurant through Class K – Catering      \*                      \*                      \***

	<b>Class M – Recreational</b>
<b>Requirements of Premises</b>	Service of liquor only during the time that the recreational portion of premises is open and available for use or with a paid lifestyle amenities service. For golf courses, liquor may be served outside the physical structure but must be adjacent to and within the property lines of golf course.
<b>Container Requirements</b>	Liquor by drink, wine by bottle/carafe, beer by pitcher not to exceed 60 oz. or by bottle not to exceed 16 oz. For lifestyle amenities facilities, wine by the drink not to exceed 6 oz. or beer by the drink not to exceed 12 oz., two drinks total per patron.
<b>Food Requirements</b>	May be served as long as it complies with all health regulations and licensing requirements.

<b>Liquor Service</b>	No outside liquor.
<b>Hourly Restrictions</b>	During recreational activity only or with paid lifestyle amenities service.
<b>Annual Fee</b>	\$2,200.00
<b>Other</b>	Cap of 13 <u>14</u> . Certified record of annual revenue shall be included with renewal paperwork for review by the Liquor Commissioner. Insurance required for outside premises.

	<b>Late Night Permit</b>
<b>Requirements of Permit</b>	Class B license holders only.
<b>Consumption</b>	Liquor service from 11:00 p.m. to 1:00 a.m. (Mon.—Fri.), 2:00 a.m. (Sat.—Sun.)
<b>Container Restrictions</b>	None.
<b>Food Service</b>	None.
<b>Type of Liquor Service</b>	Same as with Class B license.
<b>Annual Fee</b>	\$500.00
<b>Other</b>	Cap of 24 for downtown locations, cap of 44 <u>43</u> for non-downtown locations.
