ORDINANCE NO. 19 -

AN ORDINANCE AUTHORIZING THE EXECUTION OF AN ANNEXATION AGREEMENT FOR THE PROPERTY LOCATED AT 5S275 AND 5S311 NAPERVILLE/WHEATON ROAD (LEIGH SUBDIVISION)

SECTION 1: The foregoing recitals are incorporated as though fully set forth here. All exhibits referenced in this Ordinance shall be deemed incorporated and made part hereof.

SECTION 2: The Mayor is authorized and directed to execute, and the City Clerk is authorized and directed to attest, the Annexation Agreement for Leigh Subdivision attached hereto as **Exhibit C**.

SECTION 3: The City Clerk is authorized and directed to record this Ordinance and

the Annexation Agreement for Leigh Subdivision, and its exhibits, with the DuPage County Recorder upon completed execution thereof.

SECTION 4: This Ordinance shall be in full force and effect upon its passage and approval.
