Russ Whitaker, Petitioner's Attorney, discussed the proposal and detailed that the subject property consists of approximately 113 acres located at the northeast corner of Route 59 and 103rd Street in unincorporated Will County, that Wagner Limited Partnership is petitioning for annexation into the City of Naperville, and that Pulte Home Company, LLC, requests approval to: 1) rezone approximately 105 acres of the property to R2 (Single-Family and Low Density Multiple-Family Residence) for the development of single family detached homes; 2) rezone approximately eight acres of the property to OCI (Office Commercial and Institutional) for development of the Compass Evangelical Free Church; 3) approve a preliminary plat of subdivision; and 4) approve a variance from the sign code to permit signage for the residential development to be located on the Compass Evangelical Free Church parcel.

Darrell Cloud, Naperville, spoke in favor of the proposed annexation agreement.
