**SUBJECT:** Recommendation for Calendar Year 2019, First Quarter Commuter Permit

Issuance and Space Utilization Report

#### **PURPOSE:**

This memorandum provides information on utilization of commuter parking for the months of September, October and November 2018. The utilization information and data from the Calendar Year 2018, Third Quarter permit issuance are used to make a recommendation for the issuance of new parking permits effective January 1, 2019 from the waiting lists for the Naperville Station.

#### **INFORMATION:**

The Transportation, Engineering and Development Business Group (TED) surveyed the lots September 13, October 18 and November 15, 2018. The usage versus capacity for each lot is detailed in the attached spreadsheets.

The City continues to be aggressive in issuing commuter parking permits to maintain a high occupancy rate in the commuter parking lots. TED coordinates with the Police Department to receive reports when the lots reach or exceed occupancy to better track the daily usage of the lots. There was one reported day of 100% capacity for permit spaces received by TED from the Police Department during the current quarter.

#### Calendar Year 2018, Fourth Quarter Permit Issuance Results

For the Fourth Quarter of Calendar Year 2018, no new offer letters were sent to commuters for the Burlington commuter lot, Kroehler commuter lot, or Parkview commuter lot. During the period of September through November 2018, a total of ten (10) commuters with Burlington lot permits, five (5) commuters with Kroehler lot permits, and three (3) commuters with Parkview lot permits cancelled or had their permit cancelled for non-payment.

The City does not maintain a waitlist for the Route 59 commuter lot. Permits are available on a walk-in basis. During the period of September through November 2018, eighty-eight (88) commuters cancelled or had their Route 59 permit cancelled for non-payment. During the period of September through November 2018, a total of fifty-six permits were issued at Route 59.

### Calendar Year 2019, First Quarter Permit Issuance Recommendation

The number of Route 59 permits available are adjusted each quarter based on lot occupancy and the number of cancellations that occur during the prior quarter. As of November 28, 2018, one hundred eleven (111) permits are available.

TED determines the number of Naperville Station quarterly parking permits to be offered to commuters on the wait lists based on actual acceptance, lot usage, seasonal variations, cancellations, and historical data. Consideration is given to the potential number of acceptable overflow days per quarter.






