## **ORDINANCE NO. 019 -**

## AN ORDINANCE ESTABLISHING TEMPORARY TRAFFIC CONTROLS FOR THE NAPERVILLE 10K AND 5K RUN ON JUNE 9, 2019

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DuPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority as follows:

**SECTION 1**: Section VIA, No Parking Zones, and Section XII, Tow Away Zones, of the Naperville Traffic Schedule Manual are hereby temporarily amended for the Naperville 10K 5K Run from 5:00 a.m. to 11:00 a.m. on Sunday, June 9, 2019 by adding the underlined language as follows:
