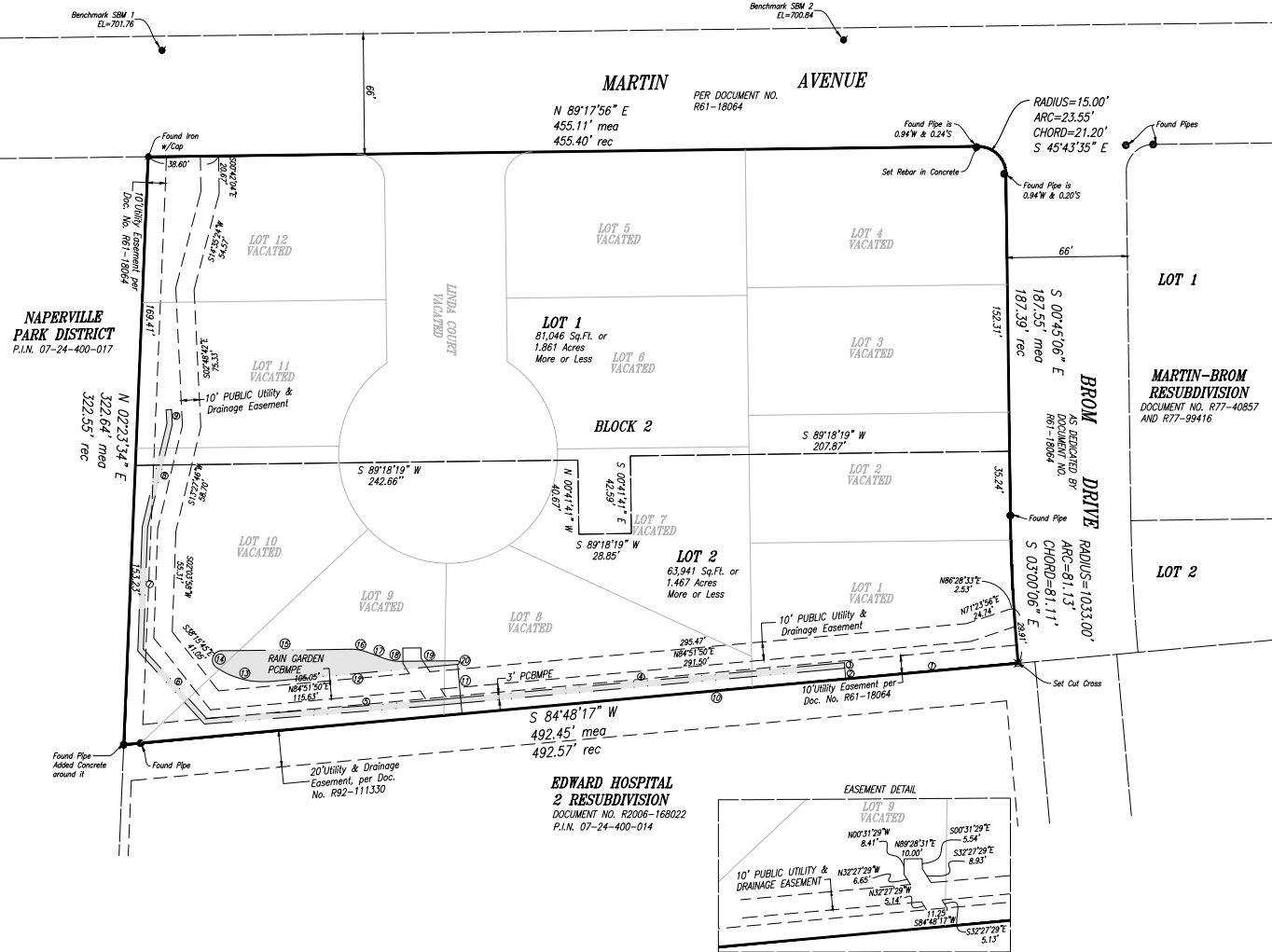

- 1) ALL LOTS IN BLOCK 2 IN BROW SUBDIVISION, THE BUILDING SETBACK LINES IN SAID BLOCK 2, LINDA COURT AND THE PUBLIC UTILITY EASEMENT ALONG THE WEST LINE OF LOT 4 AND ALONG THE EAST LINE OF LOT 5, WERE VACATED BY ORDINANCE NO. 258-69 AND RECORDED AS DOCUMENT R69-2658.
- 2) THE SURVEYED PARCEL IS SUBJECT TO THE TERMS AND CONDITIONS CONTAINED IN THE EASEMENT MADE BETWEEN NAPERVILLE ELDERLY HOMES, INC. AND COMCAST OF ILLINOIS/WEST VIRGINIA, LLC, RECORDED AS DOCUMENT R2011-13858, SAID EASEMENT IS BLANKETED OVER THE SUBJECT PROPERTY AND THEREFORE IS NOT PLOTTABLE.

PUBLIC UTILITY AND DRAINAGE EASEMENT PROVISIONS
A NON-EXCLUSIVE PERPETUAL BLANKET UTILITY EASEMENT IS HEREBY RESERVED FOR AND GRANTED OVER ALL LOTS OF THE PROPERTY DEPICTED HEREON (HEREINAFTER REFERRED TO AS THE "PROPERTY") TO THE CITY OF NAPERVILLE, ILLINOIS, AND TO THESE PUBLIC UTILITY COMPANIES OPERATING UNDER FRANCHISES OF AGREEMENT FROM THE CITY OF NAPERVILLE, ILLINOIS, AND NOT LIMITED TO, ILLINOIS BELL TELEPHONE COMPANY AND AMT, ILLINOIS, NEXUS GAS COMPANY, AND THEIR SUCCESSORS AND ASSIGNS, AND TO OTHER GOVERNMENTAL AGENCIES HAVING JURISDICTION OVER THE PROPERTY, EXCEPTING THEREFROM ANY BUILDINGS (OTHER THAN UTILITY METERS ATTACHED THEREON) ORLANDRY PLUMBING AND/OR CONSTRUCTION WITHIN THE DEVELOPMENT AS SHOWN HEREON, FOR THE PERFORMANCE OF MAINTENANCE AND OTHER CONSTRUCTION, SERVICES, INCLUDING BUT NOT LIMITED TO THE PERFORMING, REPAIR, REPLACEMENT, MAINTENANCE, TESTING, REPAIR, MAINTENANCE AND OPERATING, WINDING UTILITY TRANSMISSION AND DISTRIBUTION SYSTEMS, COMMUNITY ANTENNA TELEVISION SYSTEMS, WATER, STORM AND/OR SEWAGE SERVICES, TOGETHER WITH ANY AND ALL NECESSARY MANHOLES, CATCH BASINS, CONNECTIONS, APPURTEANCES AND OTHER STRUCTURES AND APPURTENANCES AS MAY BE DEEMED NECESSARY BY SAID CITY, OVER, UPON, UNDER AND THROUGH SAID EASEMENT, AND FOR THE RIGHT TO REAR, EXAMINE, INSPECT, MEASURE, OPERATE, MAINTAIN, EXCHANGE, REMOVE, REPAIR, TEST, AND/OR REPLACE CITY OWNED UTILITY EQUIPMENT AND METERS, TOGETHER WITH THE RIGHT OF ACCESS ACROSS THE GRADERS PROPERTY FOR NECESSARY PERSONNEL AND EQUIPMENT TO DO ANY OF THE ABOVE WORK.

POST CONSTRUCTION BEST MANAGEMENT PRACTICES EASEMENT PROVISIONS
A Post Construction Best Management Practices Easement is hereby reserved for and granted over the subject property to the City of Naperville, Illinois, its agencies, successors and assigns, or any other governmental entity having jurisdiction over the subject property, for the purpose of installing, maintaining, inspecting, testing, repairing, and/or replacing any and all necessary structures and appurtenances as may be deemed necessary by said City, over, upon, under and through said easement, and for the right to rear, examine, inspect, measure, operate, maintain, exchange, remove, repair, test, and/or replace city owned utility equipment and meters, together with the right of access across the graders property for necessary personnel and equipment to do any of the above work.

The properties within this Plat of Subdivision are subject to the provisions of the Declaration of Covenants, Conditions, Restrictions and Easements recorded on 2019 as Document Number R2019-
