**AN ORDINANCE AMENDING THE NAPERVILLE TRAFFIC SCHEDULE MANUAL TO REMOVE TWO-WAY YIELD CONTROL AT THE INTERSECTIONS OF BIRCHWOOD DRIVE AND SUNNYBROOK DRIVE, BIRCHWOOD DRIVE AND STONEGATE ROAD, AND BIRCHWOOD DRIVE AND BRIARWOOD DRIVE, TO ESTABLISH TWO-WAY STOP CONTROL AT THE INTERSECTIONS OF BIRCHWOOD DRIVE AND SUNNYBROOK DRIVE, BIRCHWOOD DRIVE AND STONEGATE ROAD, BIRCHWOOD DRIVE AND BRIARWOOD DRIVE, BIRCHWOOD DRIVE AND BRUSH HILL CIRCLE, AND TO REMOVE ONE-WAY YIELD CONTROL AT THE INTERSECTION OF BIRCHWOOD DRIVE AND COTTONWOOD LANE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, ILLINOIS, DuPAGE AND WILL COUNTIES**, in exercise of its home rule authority as follows:

**SECTION 1:** Section IIB, Two-Way Yield Intersections, of the Naperville Traffic Schedule Manual is hereby amended by deleting the stricken language as follows:

**SECTION 2:** Section XX, Right-Of-Way Streets, of the Naperville Traffic Schedule Manual is hereby amended by deleting the stricken language as follows:

**SECTION 3:** Section IB, Two-Way Stop Streets, of the Naperville Traffic Schedule Manual is hereby amended by adding the underlined language as follows:

<u>BRUSH HILL CIR.</u>	<u>Birchwood Dr.</u>	<u>19-</u>

**SECTION 4:** Section IIA, One-Way Yield Intersections, of the Naperville Traffic Schedule Manual is hereby amended by deleting the stricken language as follows:
