SECTION 1: Title 3 (Business and License Regulations), Chapter 3 (Liquor and Tobacco Control), Section 3 (Definitions) of the Naperville Municipal Code is hereby amended by adding the underlined language and deleting the stricken language as follows:

3-3-3: - **DEFINITIONS:** For the purposes of this Chapter, the following words and phrases shall have the following meanings:

ALCOHOLIC LIQUOR through CRAFT DISTILLED SPIRITS

An aluminum container containing no more than 32 ounces of craft beer or cider that is sold or offered for sale off premises.

DOWNTOWN through GROCERY STORE

GROWLER:	A glass receptacle containing no more than two (2) liters (67.6 ounces) of craft beer or cider manufactured at the licensed premises that is sold or offered for sale at retail for consumption off premises.
