ORDINANCE NO. 19- ___

AN ORDINANCE APPROVING A PRELIMINARY/FINAL PLAT OF SUBDIVISION FOR ACM AND DOG HAUS LOCATED AT THE NEC OF 95TH STREET AND REFLECTION DRIVE

WHEREAS, Manny Butera (herein after "Petitioner" or "Owner") owns certain property located at northeast corner of 95th Street and Reflection Drive, Naperville, Illinois, legally described on <u>Exhibit A</u> and depicted on <u>Exhibit B</u> ("Subject Property") and commonly known as Naperville Crossings Lot 10; and

WHEREAS, the Petitioner has petitioned the City of Naperville for approval of a Preliminary/Final Plat of Subdivision for ACM and Dog Haus Resubdivision in order to subdivide the Subject Property into two lots that will be known as Lot 25 and Lot 26; and

SECTION 1: The foregoing recitals are incorporated as though fully set forth in this Section 1. All exhibits referenced in this Ordinance shall be deemed incorporated and made part hereof.

SECTION 2: The Preliminary/Final Plat of Subdivision of ACM and Dog Haus Resubdivision, attached to this Ordinance as **Exhibit B**, is hereby approved.

SECTION 3: This Ordinance is subject to all conditions and requirements set forth in the Naperville Municipal Code, as amended from time to time.

SECTION 4: The City Clerk is directed to record this Ordinance and its exhibits and the Preliminary/Final Plat of Subdivision of ACM and Dog Haus Resubdivision with the Will County Recorder.

SECTION 5: This Ordinance shall be in full force and effect upon its passage and approval.
