DESCRIPTION

On January 31, 2012, the Chief Procurement Officer awarded the Renewable Energy Program – Strategy Development to Customized Energy Solutions (Customized) for an amount of \$25,000 (The executed recommendation is attached as Exhibit A.) The first stage was to develop and implement a program to provide residents and businesses with renewable energy options as part of their electric service; develop a working Program Business Plan to serve as a guide for Program development; and provide informational support detailing relevant issues and developments relating to Illinois renewable energy-related policy decisions and associated rule changes and developments. This work is complete.

During Renewable Energy Program Phase 2 - Management and Administration, Customized will:

- transact business on Client's behalf in meeting its renewable energy business plan objectives, including evaluating project opportunities and procuring and selling credits
- assist Client in developing residential and business information and educational Program support
- keep Client informed of any changes to Illinois renewable energy related policy that may impact its program or offerings

Renewable Energy Project Opportunity Analysis

- Customized will identify and evaluate renewable energy project opportunities for potential power purchase agreement or investment opportunities;
- develop recommended economic, geographic, and technology selection criteria for Client approval; and
- manage project solicitations where appropriate, evaluate opportunities, and make project and program recommendations

Renewable Attribute Management

- Customized will work with counterparties and brokers to identify Renewable Energy Credit (REC) opportunities;
- work with Client and counterparties to ensure appropriate state or voluntary standard REC certification:
- work with Client and counterparties to negotiate and finalize REC transactions;
- ensure that RECs are properly and fully registered or retired in the appropriate renewable tracking system (PJM-GATS), and manage the registration and administration of Client's account:

- track the settlements for any renewable attribute purchases; and
- upon Client request, Customized will provide consultation or training on GATS functionality and utilization, as well as procurement processes.

The fee for this stage and ongoing Business Administration is \$4,000/month. The \$72,000 is based on an 18-month contract.

Following the completion of this work, the City Manager approved a sole source award on December 17, 2012 to CES to perform the management and administration of the Naperville Renewable Energy Program. The agreement between the City and CES allows the two parties to renew the services if both parties are in agreement. Two extensions were approved since the original sole source in 2012. Following the completion of the first year of management which included additional services, the monthly fee for the program management was reduced to \$2,000. CES continues to perform well and both parties are in agreement that they would like to continue the relationship. CES has agreed to continue to hold their prices at \$2,000 per month.

The term of the third extension is for 18 months beginning July 18, 2016 through December 31, 2017 with the ability to extend the contract additional terms if both parties are in agreement.

BACKGROUND:

The Electric Utility contracted with Customized Energy Solutions (CES) in 2012 to develop a program to provide residents and businesses with renewable energy options as part of their electric service. On December 17, 2012, CES was approved as a sole source by the City Manager to perform the management and administration of the Naperville Renewable Energy Program and CES has successfully managed and administered the program on behalf of the Utility since.

DISCUSSION:

As the administrator of the City's renewable energy program, CES provides the Utility with brokering of wind and solar Renewable Energy Certificates. Over the past five years, participation in the program has declined approximately 18 percent. However, there are still over 2,950 program participants.

The Utility understands the importance of renewable energy as evidenced by the installation of a solar panel system on the Municipal Center roof in 2018 and work in 2019 to install a solar panel system at the Springbrook Water Reclamation Center. The Utility will continue to work to educate users on the benefits of renewable energy and the City's program in hopes of increasing participation again.

The term of the fifth extension is for twelve (12) months beginning January 1, 2019 through December 31, 2019 with the ability to extend the contract for additional terms by mutual agreement between both parties.
