We wanted to let you know that the Polo Club development, proposed to be located generally at the northwest corner of 119th street and book road, (commonly known as 23450 and 23700 w 119th street, Plainfield, IL), will be placed on the February 18, 2020 Naperville City Council agenda for consideration. The meeting will begin at 7 p.m. in the City Council Chambers at the Naperville Municipal Center at 400 s. Eagle street, Naperville, IL 60540.

The current Polo Club development plans (14th submittal) that were previously transmitted to you via ownCloud (<https://owncloud.naperville.il.us/index.php/f/3400>) will be presented to the City Council on February 18th. **However, no ordinances or agreements will be before the City Council on February 18th, and no final action will be taken.** The

purpose of the meeting is for the City Council to discuss the merits of the current Polo Club development proposal, and to provide input and direction to staff and/or to the developer during the discussion.

As usual, members of the public will be given an opportunity to address the City Council and will have up to three minutes each to speak. You may also provide comments via email if any, by the end of Monday, 2/10 for your comments to be included in the agenda packet.
