Executive Order 2020 – 5

## **EXECUTIVE ORDER OF THE MAYOR OF THE CITY OF NAPERVILLE**

## **RECITALS**

- 1. **WHEREAS**, on January 30, 2020, the World Health Organization declared the COVID-19 outbreak to be a public health emergency of international concern; and
- 2. **WHEREAS**, on March 13, 2020, the President of the United States issued a proclamation on declaring a national emergency concerning the COVID-19 outbreak, and
- 3. **WHEREAS**, on March 9, 2020, the Governor of the State of Illinois issued a disaster proclamation due to the impact of the COVID-19 outbreak and activated the State Emergency Operations Center; and
- 4. WHEREAS, on March 17, 2020, at an emergency Naperville City Council meeting a local state of emergency and disaster related to the COVID-19 outbreak was declared (see, Mayor of Naperville's Declaration of a Local State of Emergency and Disaster and City of Naperville Ordinance 20-028 pertaining to a local state of emergency and disaster); and
- 5. **WHEREAS**, effective Wednesday, March 18, 2020, all City of Naperville buildings have been closed to the public and many City staff began working remotely impacting City public business operations; and
- 6. **WHEREAS**, on March 16, 2020, the Governor of the State of Illinois issued Executive Order 2020-07, suspending on-premise consumption of food and beverages in places of public accommodation and prohibiting gatherings of 50 people or more; and
- 7. WHEREAS, on March 20, 2020, the Governor of the State of Illinois issued Executive Order 2020-10, requiring that all non-essential business and operations cease and requiring all individuals currently living in the State of Illinois to stay at home or their place of residence except as necessary to perform essential activities; and

- 8. **WHEREAS**, certain parking restrictions contained in the Naperville Municipal Code may interfere with or make voluntary compliance with Executive Order 2020-10 more difficult and the temporary suspension of certain restrictions may assist in voluntary compliance with the Order.
- 9. WHEREAS, the City of Naperville is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs including, but not limited to, the power to regulate for the protection of the public health, safety, morals and welfare, including taking immediate emergency measures to protect the public welfare in response to the COVID-19 outbreak; and

**THEREFORE**, by the powers vested in me as the Mayor of the City of Naperville, and pursuant to 65 ILCS 5/11-1-6 of the Illinois Municipal Code, 20 ILCS 3305/11 of the Illinois Emergency Management Agency Act, Sections 10-1-1 and 1-8D of the Naperville Municipal Code, the Mayor of Naperville's Declaration of a Local State of Emergency and Disaster and City of Naperville Ordinance No. 20-028, I hereby order the following:

<u>SECTION 1</u>: Recitals. The Recitals set forth above are found to be true and correct and are hereby incorporated herein and made part hereof in their entirety by reference as though fully set forth in this Section1.

<u>SECTION 2</u>: Certain Parking Restrictions. Due to the current conditions and limitations placed on our citizens and the Naperville Police Department because of COVID-19, effective immediately, there is a moratorium on the overnight parking, time limited parking, and commuter parking lot violations, including in Section 11-2A-2 (Limits on time generally), Section 11-2A-3 (Limits on time Central Business District) and Section 11-2A-8 (Overnight parking) of the Naperville Municipal Code, until such a date as later determined, in writing, by the City.

The Naperville Police Department shall continue to enforce other stopping, standing or parking violations, including unauthorized use of parking places reserved for persons with disabilities, blocking private and public driveways and fire hydrants, fire lane violations, and any other violations that may pose a danger to the public or restrict the ease of traffic movement.

<u>SECTION 3</u>: Savings clause. If any provisions of this Executive Order or its application to any person or circumstance is held invalid or unenforceable by any court of competent jurisdiction, this invalidity or unenforceability does not affect any other provisions or application of this Executive Order, which can be given effect without the

invalid or unenforceable provision or application. To achieve this purpose, the provisions of the Executive Order are declared to be severable.

**SECTION 4**: **Effective date**. This Executive Order shall be in full force and effect from 12:00 A.M. on the date listed atop page one of this Order.
