NOTICE OF PUBLIC HEARING BEFORE THE CITY COUNCIL OF THE CITY OF NAPERVILLE FOR THE PROPOSED ESTABLISHMENT OF SPECIAL SERVICE AREA NO. 33 (DOWNTOWN MAINTENANCE EXPENSES AND MARKETING)

NOTICE IS HEREBY GIVEN that on August 18, 2020, at 7:00 p.m, a public hearing will be held by the City Council of the City of Naperville to consider the proposed establishment of Special Service Area No. 33 consisting of the real property described in this notice. The meeting will be held using Zoom Webinar Technology. Please visit https://naperville.legistar. com/Calendar.aspx for information on how to watch and participate. An accurate map of the proposed Special Service Area is on file in the office of the City Clerk and a reduced copy of the map is attached as Exhibit A. The complete legal description for the proposed Special Service Area is attached as Exhibit B. A list of the parcel identification numbers of each parcel located within the proposed Special Service Area No. 33 is attached as Exhibit C.

All interested persons, including all persons owning taxable real property located within the proposed Special Service Area, will be given an opportunity to be heard at the public hearing regarding the establishment, the boundaries, and the levy of taxes within the Special Service Area and may file with the City Clerk a written objection as provided by applicable law.

The purpose of the proposed establishment of Special Service Area No. 33 is generally to provide special municipal services to the designated area that include: parking lot operations and maintenance, maintenance of the public parking garages, custodial services, sidewalk and parking lot snow removal, maintenance of landscaping, streetscape, and street lighting, holiday lighting on parkway trees and buildings, sidewalk maintenance including brick paver repair, special directional signage, capital improvements, and efforts to market the downtown area to provide services that will promote business expansion and retention, and other special services are may be determined to be necessary to properly maintain the downtown area, together with the approved costs of engineering, construction, inspection, legal fees, the City's costs for mailing, publication, recording, and other necessary and incidental expenses incurred in establishing the Special Service Area.

If Special Service Area No. 33 is established, a special tax will be levied for a period not to exceed 5 years and not to exceed an amount of 2.5% per annum of assessed value, as equalized, against the property included in the Special Service Area. The proposed amount of the tax levy for special services for the initial year are 1.5193% per annum of assessed value, as equalized, against the property included in the Special Service Area.

The City Council shall hear and determine all protests and objections at the hearing and the hearing may be adjourned to another date without further notice on a motion to be entered in the minutes fixing the time and place of its adjournment. The City Council shall be authorized but is not required to take final action on an ordinance establishing the Special Service Area after the conclusion of the public hearing.


