## ORDINANCE NO. 20-

## AN ORDINANCE TO ABATE A PORTION OF THE 2020 TAX LEVY FOR THE CITY OF NAPERVILLE

WHEREAS, on the 15th day of December 2020, Ordinance No. 20-\_\_\_\_, being a tax levy ordinance for the fiscal year commencing January 1, 2021, and ending December 31, 2021, for the City of Naperville, DuPage and Will Counties, Illinois, was passed and approved; and

WHEREAS, the ordinance provided for the levying of taxes in the amount of \$18,052,070 for the Debt Service Fund; and

**WHEREAS**, the corporate authorities of said City will have on hand sufficient funds to meet an additional portion of the amounts levied for the above stated purposes for the tax year 2020 when the same becomes due;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY

OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS, in exercise of its home rule authority, as follows:

**SECTION 1**: That the levy for the tax year 2020 approved by Ordinance No. 20— on December 15, 2020, being the ordinance for the tax levy and the amount thereto, for the fiscal year beginning January 1, 2021, and ending December 31, 2021, for the City

of Naperville, DuPage and Will Counties, Illinois, for the following purposes and in the amounts set forth shall be and the same is further abated as follows:
