CITY OF NAPERVILLE PUBLIC MEETINGS UPDATE:

On Friday, June 12, 2020, an amendment to the Open Meetings Act was signed into law. This new law replaces the gubernatorial executive order concerning the Open Meetings Act and allows public bodies to temporarily conduct meetings remotely during a state of emergency, subject to certain requirements, including a determination by the head of the public body that an in-person meeting is not practical or prudent.

Pursuant to Section 120/7(e) of the Illinois Open Meetings Act, the continuation of the Governor's disaster proclamation, and Mayor Chirico's executive order determining that in-person public meetings are not currently practical or prudent because of the Covid-19 pandemic, we are holding December 9, 2020 Riverwalk Commission meeting remotely.

TO JOIN A MEETING: The meeting will be conducted using the Zoom Video Conferencing. You do not need to download any software or create an account to participate.

For iPhones, use the iPhone one-tap number provided on this agenda.

For telephones, dial one of the numbers provided and join the meeting by using meeting ID and password provided on this agenda.

Once connected to the meeting, press *9 to "raise your hand" and wait for the Chairman to recognize you. When it is your turn to speak, you will be unmuted. There will be a few second delay after you are unmuted until your mic will be live. Please identify yourself for the public record and speak clearly.

1. Moser Tower Rehabilitation - Bill Novack

ERA has provided and reviewed preliminary plans for the repair of the

Moser Tower with the Planning, Design and Construction (PDC) Committee. The timeline for the project going to bid will be in late winter with construction beginning in spring and taking a full construction season for completion next year.

2. Riverwalk Master Plan - Pat Kennedy

Kennedy reported that subcommittees are being formed to address Communications and Fundraising for the Riverwalk 2031 Master Plan. The Park District is working with the Riverwalk Foundation and City Staff to identify restoration projects and establish a process to scope, design, bid, oversee and build the projects.
