The City of Naperville Team,

My name is Heather Fugate, and I am the School Principal at KLA Schools of Naperville. I learned from Selvei that she is pursuing an opportunity to start a KLA Schools in Beebe Dr, near 75th street and Route 59. I think it is important to share our story during the COVID-19 pandemic, especially how, together with Selvei's leadership, support from our incredible families, and commitment from our dedicated teachers, we have come out stronger and more resilient than ever before.

February 2020 was a month like any other at KLA Schools of Naperville and Plainfield, so we thought. In reality, it was the last "normal" month of the year and possibly for a long time. The month of March brought a very dark cloud over our country and the world at large. The facts about the COVID-19 virus, how quickly it was spreading, and how deadly it could be were becoming public. This virus was no longer something China was dealing with, it was in our backyard now, and we were alarmed and concerned about the ramifications this pandemic was going to have on our lives.

There were conflicting reports from many sources flooding our media. It was an extremely frightening threat that sent people in mass to grocery stores cleaning out shelves of essential supplies. No one knew if the world would shut down or how much of these supplies would be available soon. The only thing our leadership team knew for sure was that we needed to be socially responsible and look out for the well-being of our children, families, and educators. We calmly reflected on the options and sorted through what we knew were facts about the situation. As always, we surveyed our families for their input, which led to a tough decision to close the schools' doors for in-person learning until we understood better what we were dealing with at that time. In the Naperville school, we had only been open for five months and just starting to build our enrollment, and Plainfield was near capacity.

The same day, shortly after we voluntarily closed the schools, there was a mandate put out by the Governor of Illinois, declaring an emergency to shut down all daycare centers among all other non-essential businesses. Some daycares were able to stay open if they applied for emergency licenses, but the families who could utilize the services were only essential worker's children. It was not enough for our school population children to even consider doing this at the time. We decided to offer remote learning from the next day onwards. Our Pedagogical team worked on that weekend to prepare learning-from-home resources, and our teachers jumped in and provided zoom assemblies and enrichments immediately. Things were still very unclear at the time, and people were beginning to panic more amidst the stories coming from Italy and other places facing large outbreaks.

We need to make tougher decisions during these first couple of weeks of offering remote learning. Many other schools and daycare centers were laying off their staff due to the closings. Initially, outsiders advised the same for us as well. Selvei, our team leader, had other plans for our staff and leadership team. She intended to keep as many staff on as possible, and we set out to figure out how we could do this. There were many Zoom calls and conversations about how to continue offering learning opportunities and meaningful connections to our children, teachers, and families while meeting our payroll needs and how we would handle tuition if the closure were for an extended time. One thing was clear; we could not charge our families tuition without providing our in-person services, and we needed to be there for the families during this difficult time.

We decided to continue remote learning for our students and offered the parents to pay what they felt was reasonable or affordable during the closure. Between what the parents paid and what Selvei could secure in PPP loans, we could continue our services without furloughing full-time employees. It was unlike what any other school was doing during this time. We kept the whole team together, and we all worked remotely. Although the school was closed for in-person learning, we all continued to work full-time, and we made sure to make this time count and be productive.

Our plan for working during the closure was threefold. First, we would offer remote learning and enrichment for the children in the mornings and afternoons. Second, the educational webinars by experts for our parents and educators, and third, the team collaborated and did professional development for the remainder of their time. Besides, Selvei noticed several other schools in the neighborhood were closed, and families and some children had no choice but to stay at home with no remote-learning opportunities. At these unprecedented times, we felt it is of paramount importance to extend our help to the community at large outside of our KLA families and be there for one another. Hence, we made our enrichment programs available to the public for free, giving the children and families meaningful connections, especially during these difficult times. It was widely recognized and leveraged by more than 150 community members in April and May 2020.

Our educators stepped up and did incredible programming as leaders to help make the enrichments, learning at-home materials, and Zoom assemblies as fun and educational as possible. We mailed seeds to all of our children's homes to grow the seedling and later bring them to the school garden to harvest. Our KLA families appreciated the efforts, and the tuition donations were extremely generous.

Some of our families even paid full tuition throughout the closure and beyond. These difficult times showed us what we were capable of doing and how incredibly kind our families are. We were truly humbled. This

pandemic wasn't the end of the world as it had felt at the start. It was indeed very distressing and devastating to our communities. Still, we were making the best of the situation and, as a team, keep contributing positive things to help brighten these days.

To sustain the positive attitudes, we decided to focus on gratitude during the pandemic closing. Selvei bought the entire team a gratitude journal to write in daily. The gratitude journals were sent to everyone's homes as a special gift from her. The gesture inspired many on the team to redirect their energy to gratitude, and everyone was grateful for the gesture. There was an outpouring of support and appreciation for Selvei's initiative. The gratitude practice is still flowing through the schools daily; it has become a part of who we are and our core values.

Our very own KLA Parents, Dr. Summers, a Psychologist, and Dr. Consilio, a mindfulness expert, generously offered free live seminars to our families and educators. At the time of uncertainty and during the most unprecedented times, learning what we can control and what we cannot control helped us with our personal growth. We also emphasized self-care for our educators and parents. Selvei provided resources to our families through social-emotional consultants and bought self-care books for our teachers as it's one of the ways we build our resiliency.

The month of May came quickly and with it were significant events for the school, teacher appreciation, parent appreciation, and graduation for the prekindergarten and kindergarten children. This year we wanted to celebrate in a big way but knew this would have to be a creative endeavor. The leadership team put their heads together and decided to combine both teacher and parent appreciation events in one week. We believe Parents are the first and most influential teachers for children. For the parents, we wrote a poem, put it on a card, and gave each family a beautiful flower arrangement and bookmark. The team went out and delivered these items personally to each family's home. We spent an entire day making the arrangements for the families at both schools.

We felt so blessed to have so many dedicated, creative team members to make this all a reality. Then, for the teachers, we made them beautiful gifts and had a parade at each school. The families were able to drive by and greet their teachers.

Some families made signs and other unique gestures of thanks. It was so good to see the children and families, even if it was from a distance in their cars. Everyone forgot about the pandemic and enjoyed the moment.

The graduation program was conducted through Zoom; however, the educators' team delivered the caps, gowns, and diplomas to each child's home before the Zoom ceremony. The looks on the children's faces seeing their teachers at their homes were priceless.

The ceremony was not like other years; however, it was unique in ways, where grandparents from Spain, Bangladesh, and many other countries could join the ceremony. It marked our first Zoom event (and one of many to come) and showed how we could pull together as a team and make sure there was some closure for our graduating children. We were also able to show off a beautiful slide show and presentation the

team put together. We were so happy we decided not to cancel all our events and try to make the most of what we could do. It made the children and families smile and brought some normalcy to their lives, even if just for a moment.

At the beginning of June, we were able to open our doors for children under certain conditions set forth by the CDC and DCFS. We submitted a plan to operate during the pandemic safely, or at least as safe as we possibly could. We needed to follow many new rules and regulations, and everyone above two years old required to wear masks. It included families not being able to come into the classrooms or even the building, staffing challenges, and an incredible amount of daily cleaning and sanitizing. We wondered how we would get it all done. We revised staffing plans, checklists and put together daily health questionnaires. We even purchased a thermal temperature unit for our vestibule. We went above and beyond what anyone else was doing, and Selvei would not have it any other way. She is a firm believer that what is best for children must be what we do, even if it means more time and money. No shortcuts were to be taken with this re-opening like any time.

June 1st marked the first day we were to re-open. Unfortunately, the world had other plans for us that day. Naperville and surrounding communities were under siege by looters and protestors who were angry with George Floyd's tragic death.

It seemed like things couldn't get worse for 2020. We decided to delay our opening two more days, so authorities could handle what was happening in the communities across the nation. After all, we needed to keep children safe, and being at home was best for those two days.

Both the Naperville and Plainfield schools re-opened on June 3rd, 2020. Each school had very few children, Naperville had a dozen students about what we opened with, and Plainfield went from approximately 160 students to 25. We had far more staff than we needed for those few children. We did the best we could with the few hours we had to give out and set our focus on enrollment. How would we ever get back to where we were in a pandemic? We were determined to get there no matter what it took, including working Saturdays to do in-person tours.

Fast forward to 10 months later, we are now in need of more staff and have grown tremendously at both schools. Naperville has surpassed the enrollment it had before the closure, and Plainfield is getting very close to pre-covid enrollment. It was a lot of hard work, extra hours, dedication, and teamwork on the teaching team and the leadership team. As a result, our reputation and standing in the community have been elevated by our choices and actions during these most unprecedented times. We are very proud to say we not only survived COVID, but we flourished in many ways, both professionally and personally.

Biggest lessons learned from our year living with COVID? We are all capable of things we never thought possible, and the children are amazingly resilient. We are beyond proud of how they adapted to the "new normal" use of masks, constant handwashing, social distancing, and drop-offs at the front door. What we thought was going to be near impossible happened, and we not only survived it, but we thrived. Although

the next school year will likely look very different from this one due to vaccines' release, it has been a bittersweet year of learning and self-discovery—a story to share and pass on to others in need of inspiration.

Selvei's vision is to leave traces in the community by nurturing young minds to be respectful, caring citizens and empathetic leaders. Selvei models these values and enables us to foster a sense of belonging in the community and develop relationships with understanding. As a token of our appreciation to our families, we bought bulk gift cards from local small family-owned restaurants and gave them to our families during Thanksgiving. Some of our families gave them to our teachers. It is one example of how our KLA community cares deeply about one another and our community.

I request you to approve Selvei and her family's request to build a KLA Schools in Beebe Dr. I am excited to see the new school's opportunities to the South and the Western part of Naperville and surrounding communities.



It is my pleasure to write a letter of support for KLA Schools of Plainfield and Naperville in opening up a third school, located in Naperville. I write to you as both a parent and as a collaborator with the KLA Schools team. I first met Selvei Rajkumar, owner, and Principal Erica Koegel, when I enrolled my son Connor into KLA in 2015 when he was not quite 2 years old. Very quickly, I saw how much care and dedication the staff members and teachers put into the quality of education and support they give to both the children and the parents. I had not experienced before such a high level of encouraging parental involvement and feedback at many various levels and stages of the learning process. Parents have the opportunity to be a part of specialized committees, events, and even be a part of the classroom learning environment, as much as they are interested in doing so. It was so refreshing to see that level of commitment coming from all of the staff. I could tell that KLA truly and deeply cared about their students' wellbeing and wanted their students to grow, to flourish and that each teacher spent time tailoring approaches to their specific classrooms and individual students.

I have seen that both Connor and Klara's teachers have taken the time to learn the best ways that each of them need to learn and to do their best to provide those environments. At any time, if I have any questions or concerns, or would like to talk to the staff about Connor or Klara's development and performance, I am met with enthusiasm and open ears. This, to me, is so invaluable as a parent.

As an educator myself, I take particular care in the learning environment my children engage in. After joining the KLA family, I shared my educational background and interests. I am a writing professor at Lewis University with a specialization in incorporating mindfulness and wellbeing into the classroom, as well as offering teacher support, professional development, and support to all with mindfulness, wellbeing, and resiliency-building. Several years ago, KLA invited me to offer workshops and professional development to their teachers, as well as parent workshops/talks on mindfulness to best help and support themselves and their children. I was excited about the collaboration and happily accepted. Now, years later, I am collaborating with

I write this email in support of the proposed new KLA School be located near Costco in between XSport Fitness and WalMart on Beebe Dr near 75<sup>th</sup> street.

My name is Andrew McCree, and I have served as an administrator for early childhood programs in Illinois public schools over the past ten years. Early childhood is both a lifelong passion and profession for me. Over my career I have studied and seen first-hand the positive impacts early childhood education can have on individual children, families, and communities.

Professor James J. Heckman is the Distinguished Service Professor of Economics at the University of Chicago. Professor Heckman won a Nobel Memorial Prize in economics for his research on the economic gains from investing in early childhood development. He found that quality early childhood development strongly influences the health, economic, and social outcomes for individuals and societies. Professor Heckman and his colleagues' newest research finds a 13% return on investment for comprehensive, high quality, birth-to-five early education.

Publications in The Daily Herald and The Beacon-News have proclaimed that 1 in 4 children are starting kindergarten unprepared to learn at high levels. This proclamation was based on the 2017-2018 implementation of the Kindergarten Individual Development Survey that collected data on children's math; language and literacy; and social and emotional development. Although your local school districts continue to serve children, families, and communities at high levels, it will take additional supports to meet the needs of all children within any community.

The Illinois State Board of Education promotes a Birth-Third Grade (B-3) Continuity Project to create a comprehensive, high quality, early education as described in Professor Heckman's research. Components of this project include community partnerships, family engagement, aligned curriculum and instruction, aligned assessments, data driven improvement, and supported transitions. My experiences with KLA-Plainfield and KLA-Naperville have shown me their dedication to providing high quality early education services in all of the listed areas.

KLA's vision for early childhood education aligns with the B-3 Continuity Project. They provide services for children from infants through kindergarten, additional enrichment opportunities, and before-after school care for school-aged children. Perhaps KLA's greatest strength is their aligned curriculum and instruction through their Reggio Emilia Approach to learning. This approach includes long term project-based learning with child research and investigations. The Illinois State Board of Education supports project approach and project-based learning that allows child-led investigations based on inquiry as best practice.

I hope this letter will help you with your decision when considering the approval for additional KLA schools. There is a need for high quality early childhood services, a high return on investment for high quality early childhood services, and KLA schools' approach to learning continues to meet and exceed standards set forth by the Illinois State Board of Education.
