## **ORDINANCE NO. 021 -**

## AN ORDINANCE ESTABLISHING TEMPORARY TRAFFIC CONTROLS FOR THE DOWNTOWN NAPERVILLE TRICK-OR-TREAT ON OCTOBER 31, 2021
