**3.** Recommend approval to establish an all-way stop at the intersection of Fairway Drive and Country Club Boulevard.

Dr. Delach stated that she was in agreement with the recommendation to install a four-way stop at the intersection of Fairway Drive and Country Club Boulevard. She has concerns with vehicular travel through the intersection from her home in Atwater as well as pedestrian crossings.

The Transportation Advisory Board was supportive of the request. Mr. Gustin shared his personal concerns with the intersection and expressed his support.
