#### **BACKGROUND:**

Bid 18-254 was advertised to procure microprocessor based relays and supervisory control and data acquisition (SCADA) equipment to enhance protection of utility equipment and telemetry information to the Electric Utility's control center. This equipment will be installed on 34.5kV sub-transmission lines at four electric utility substations and will reduce customer interruptions as well as provide more accurate load information for data analysis by utility engineers. Utility staff will install and commission this equipment.
