BACKGROUND:

In January 2019, the Water Utilities issued Bid 19-064, SCADA Maintenance Services, to contract with a firm for maintenance and troubleshooting services on the supervisory control and data acquisition (SCADA) system, which remotely monitors and operates the City's water supply, storm water pumping and wastewater facilities. Work under this contract includes scheduled maintenance, troubleshooting and repair of remote terminal units, human machine interface (HMI) and programmable logic controller (PLC) equipment at the Springbrook Water Reclamation Center and equipment located throughout the City's water supply, water distribution, storm water pumping and sanitary sewer collection systems.
